5. Information Matters:

- Superintendent's Report:
a. Dean College Partnership: Mrs. Sabolinski noted the wonderful partnership that has formed with Dean College. Each month they meet to discuss academic partnerships for our students.
b. MSBA: Mrs. Sabolinski noted that the MSBA is requesting additional data on building permits.
c. FHS Open House: Mrs. Sabolinski stated that this went very well. She has also received positive feedback from parents.
Mrs. Sabolinski noted that next year's long composition portion of the MCAS is scheduled for a $1 / 2$ day of school. She suggests moving the $1 / 2$ professional development day to April 5th to give students a full day to complete the test. She also noted that this will be an action item for the next meeting.
- School Committee Sub-Committee Reports: Mrs. Rohrbach said that at the last Budget Sub-Committee Meeting, they discussed the capital process at length. She also noted that the House \& Senate Ways \& Means Committee announced that Chapter 70 funding will be less that what they received this year.

- Mrs. Sabolinski stated that Bye, Bye Birdie will be held in the High School Lecture Hall this Thursday, Friday and Saturday evening. She also noted that Lifelong Learning will offer the FHS Experience August 9-13. Lifelong Learning will also be piloting a summer program for $3 \& 4$ year olds. If it is successful, it may roll into a playgroup throughout the school year. She also mentioned that the class of 1960 is planning their 50th reunion.
