




PROGRESS TO DATE ON THE TRAIL

The Franklin & Bellingham Rail Trail Committee was formed in 2009 as a town project of the Franklin Odd Fellows. The response from the community was great and we later joined with the Town of Bellingham.

Dedicated to the task of upgrading the Southern New England Trunkline Trail (SNETT) into a shared-use path for Franklin, Bellingham and neighboring towns for walking, jogging, biking & horseback riding. Owned by the State (DCR) and considered a linear state park connecting our communities.

We attained 501(c)(3) status as a division of the Grand Trunk Trail Blazers. We now have a parking lot, kiosk & benches at the trail head on Grove St. and security gates on Spring St. The trail has been leveled from Grove St. to Prospect St and we recently obtained our first State Grant that will widen and level a major section in Bellingham and add security gates at Lake St.

There is much work remaining and room on our committee for more interested members. We need your help! This trail is in your back yard and its development will benefit all of our citizens for generations to come.

One of Franklin's lesser known paths is actually one of he longest trails in southern Mass. Rail trails are created when abandoned rail lines are converted into public trails for use as pedestrian walk ways and picycle paths. These trails provide a safe environment or riding bikes, horses, skating, walking or jogging, and generally encourage people to exercise outdoors.



The trail is actually the site of the former "New England and New York" railroad, which means that it's elatively flat. The flat grade will make walking, ogging, bicycling or simply commuting from one place to another that much easier and more enjoyable.



The beginning of the trail is marked by a large sign on Grove St. about ½ mile north of King St. & about 2 miles south of Route 140.

A 10 space parking lot has been built by the Town of Franklin across the street from the trail head on Grove St. and other parking areas will be in development as we progress.



The potential of the SNETT trail is enormous, but a grass roots effort is needed to initiate funding for improvements. The State Department of Conservation & Recreation (DCR) and the Franklin & Bellingham Rail Trail Committee have joined forces to develop this valuable resource. They meet on the 2nd Tuesday night of every month at the Franklin YMCA. They are trying to raise awareness about the trail's existence, and are seeking the public's help to push for state, private funding, and granting agencies to rehabilitate the SNETT.

TOWN COUNCIL PROPOSAL OF CHARTER AMENDMENT TO VOTERS: TREASURER-COLLECTOR TO BE CHANGED FROM ELECTED TO APPOINTED POSITION

WHEREAS, the Town Administrator has proposed an amendment to Franklin's Home Rule Charter, as provided in G.L. Chapter 43B, Section 10(b), to change the Treasurer-Collector from an elected to an appointed position, and

WHEREAS, the Town Council has ordered and held a public hearing to consider said proposal, after having published notice thereof, all as provided in G.L. Chapter 43B, Section 10(b),

NOW THEREFORE, BE IT RESOLVED THAT the Franklin Town Council:

 Proposes to the voters that the Town of Franklin Home Rule Charter be amended as follows:

Amend

Article Three Elected Town Boards and Officers Section 1 General Provisions by striking in 3.1.2: "(b) a Town Treasurer-Collector" and by re-lettering the remaining positions.

Amend

Article Four The Town Administrator Section 2. Powers and duties by adding, a new subsection 4.2.6, as follows:

- 4.2.6 The Town Administrator may appoint a Treasurer-Collector, on the basis of merit and fitness alone, subject to the following process:
- (a) Interview of potential candidates and selection of final candidate or appointment will occur in consultation with, but not limited to, at least one member of the Town Council (as determined by the Chair of the Town Council), at least one member of the Finance Committee (as determined by the Chair of the Finance Committee), and the Comptroller,
- (b) Final appointment is subject to ratification by the Town Council.

<u>Amend</u>

Article Eight Transitional Provisions Section 1 Effective Date by adding: 8.1.2 An amendment to this charter to change the Treasurer-Collector from an elected to an appointed officer shall be

effective when approved by the voters at the general town election, provided that the incumbent Treasurer-Collector shall serve the remainder of his current term.

- 2. Directs that a copy of this resolution be submitted to the Attorney-General's office and the Department of Housing and Community Development for their review, as provided in G.L. Chapter 43B, Section 10(c).
- 3. Directs that, subject to the Attorney General's report, the proposed charter amendment be submitted to the voters for their approval at the next general election of town officers to be held on Tuesday, November 5, 2013, as provided in G.L. Chapter 43B, Section 11, said proposed charter amendment to appear on the ballot in the form specified in said statute.
- 4. Authorizes and directs the Town Administrator and Town Attorney to take any and all additional action required to submit said proposed charter amendment to the voters for their approval or otherwise to implement this resolution.
