
PAVEMENT MANAGEMENT PROGRAM 2011

Rating Scores: degradation over time








<u>TYPICAL WATER / ROAD REPLACEMENT</u> <u>COST SCENARIO</u>

Example: Crescent Street area







DISCUSSION: Mr. Donovan reviewed his family's accomplishments, the many groups DeVita's Market has sponsored over the years and his plan to not become a "package store", but to add to the existing items available at his variety store. As a result of the 2010 census the town received an additional all alcoholic beverages off premises (Package Store) liquor license to its quota of liquor licenses. The following is the procedure followed when we picked up a license as a result of the 2000 census.

• Advertise the availability of the liquor license.

The advertisement will state the date the applications must be submitted and the hearing date before the Town Council.

- Conduct a hearing at which the applicants will be allowed to make their case before the Council in support of their application.
- Council will decide based on a set of criteria which may include:
 - 1. Will the license be used to enhance the economic development of a neighborhood?
 - 2. Will it enhance the quality of life for the citizens of Franklin?
 - 3. Is it near a school or place of worship?
 - 4. Other?

Chairman Robert Vallee called the March 13, 2002 meeting to order at 7:00 PM. Present were Chairman Vallee and Councilors Phil Evans, Paul Cheli, Julio Renzi, Judith Pfeffer, Mark Brady, and Carlo Geromini.

Also present were Town Administrator Jeffrey Nutting, Assistant to the Town Administrator Maxine Kinhart, and Town Attorney Mark Cerel.

A. LICENSE TRANSACTIONS – Public Hearing Applications: All Alcoholic Beverages Package Store License

Star Markets Company, Inc. - 7:00 PM

Atty. Louis Cassis presented a request for change from Beer and Wine to All Alcohol license. If this license is granted, Star Markets will also be asking approval for change in placement of alcohol display.

When cashiers are under age, the computer locks for a sale of alcohol and an adult takes over the transaction.

Brady: Do you use this concept in other stores?

Answer: Other stores have Beer and Wine licenses. Newton may already have All Alcohol. The check-out system is the same.

Kinhart: This is a not a change but a new license application. If it were granted, the Beer and Wine license currently held by Star Markets would become available.

Jay Gayatri, Inc. – 7:05 PM

Atty. Eliot Brais presented the request for Arunkumar and Manish Patel of Old Gold Convenience Store.

Mr. Patel and his son are principals, in the store 60 hours a week, and have had no violations re. their Beer and Wine license. Mr. Brais noted that other applicants would have businesses adjacent to other licensed alcohol dealers. This location is in a separate part of town at the intersection of Cottage and Union.

DeVita's, Inc. - 7:10 PM

Atty. Peter Padula presented the case for DeVita's Market. They, too, now have a Beer and Wine license and would like the All Alcohol. Mr. Padula cited the numerous contributions of the Donovan family to the community and the long service records of their employees. The only incident ever even investigated was 17 years ago - no violation was found. This store has great access, and is a market as well as a liquor store. Zoning is already commercial. It has been in operation since 1978.

AMC Liquors, Inc. – 7 :15 PM

Richard Cornetta, atty. for AMC Liquors, presented the petition of owner Carol Costello and her daughter, Ashley Anderson, manager on the license.

Their location next to Dunkin Donuts is a clean retail site with adequate parking in a newer commercial development, Silver Maple Commons, on King Street. This location would offer an alcohol dealer in a unique location, separate from other licensees.

This is a family business. Jamie Mucciarone, who will work part-time, is also a full-time policeman. His brother Mark Mucciarone is a full-time liquor salesperson. Carol has secured a lease on this property in the belief that this location is the best for Franklin. Costello and Anderson were the first to apply and have also joined the Massachusetts Package Store Association. Employees will obtain certification under the VAT program.

Motion to close hearing: Geromini Second : Brady Vote : 7-0

Motion to award this license to AMC Liquors, Inc: Cheli Second : Pfeffer

Brady : Franklin does not need another liquor store. As long as this license is available, however, we need to award it or face repeated application hearings.

Evans : He agrees that the town does not need another package store. If this license is awarded, however, DeVita's Market would be the best recipient because of its downtown location. We need to take care of our existing commercial center. He would prefer to give the license to DeVita's.

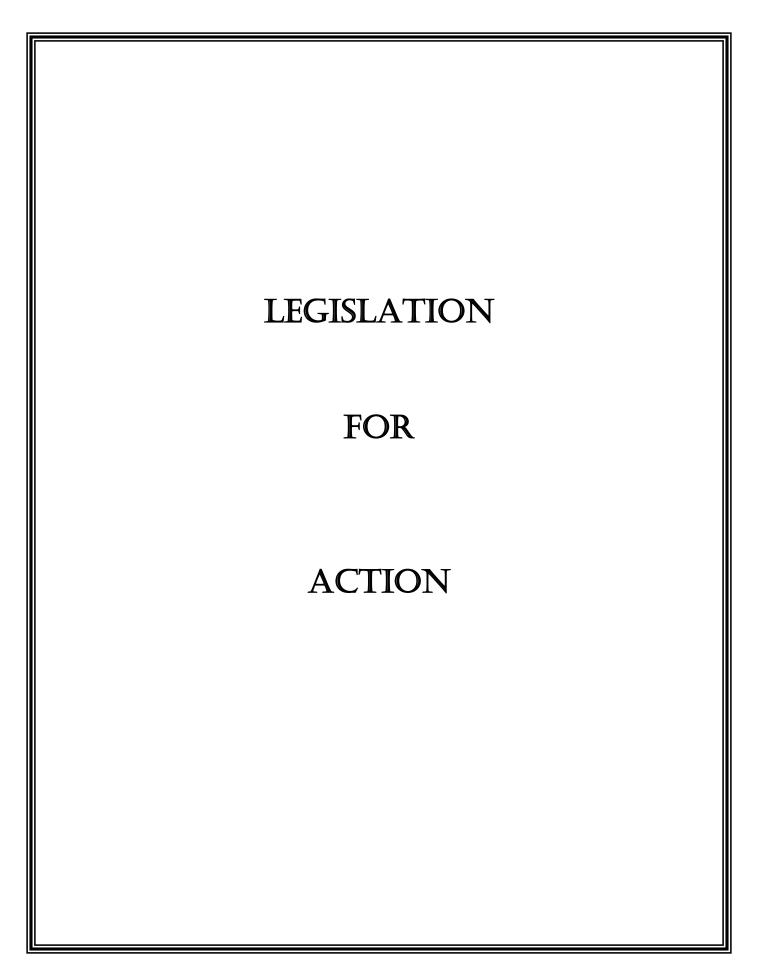

Community Builders - Affordable Senior Housing

TA Nutting reiterated the history of this site. The town gave 5 acres behind the high school to The Community Builders to develop 60 units of affordable senior housing with the help of a 202 HUD grant. That grant was denied. Now The Community Builders are proposing the original 60 units and an additional 50 condominium units on the full 22 acre site. All units would remain affordable. Apartment units would be approximately 540 sq. ft. Condos would be 1000 – 1100 sq ft.

Developer John Juhl presented the master plan and expressed the hope of The Community Builders that they will receive funding for this project.

NOW, THEREFORE, BE IT RESOLVED that the Town of Franklin purchase the land containing buildings and improvements located at 92 Wachusett Street, title reference: deed recorded at Norfolk County Registry of Deeds in Book 31895 at Page 588, for the sum of one hundred, fifty-nine thousand, one hundred dollars (\$159,100) for access to abutting Town-owned land, as well as public recreation and other municipal purposes, and that the Town Administrator, in consultation with the Town Attorney, be authorized to execute a purchase and sales agreement containing said price and such other terms and conditions as the Town Administrator determines to be in the Town's interest and to execute any other documents and take any other action necessary to consummate the purchase, and **BE IT FURTHER RESOLVED** that the sum of one hundred, sixty-one thousand dollars (\$161,000) be appropriated from the open space account to fund said purchase, together with related engineering, legal, and other closing expenses, if any.

Per Franklin's instruction, Waste Management, our contractor for curbside solid waste and recycling collection, observes eleven (11) recognized holidays. During those holidays trash and recycling pick-up is delayed one (1) day. Presently the holidays that we observe are:

New Year's Day	Martian Luther King Jr. Day
Patriots Day	Memorial Day
Labor Day	Columbus Day
Thanksgiving Day	Christmas Day

President's Day Independence Day Veteran's Day

Going forward for Fiscal Year 2015 (starting July 1st, 2014), I would suggest that we observe only the six major holidays for delayed pick up of trash and recycling. The six holidays would be the following:

New Year's Day	Memorial Day
Labor Day	Thanksgiving Day

Independence Day Christmas Day

I feel that by reducing the holiday list we will be able to reduce confusion and improve services, particularly during the winter months. Four of the holidays that I would like to eliminate occur during winter months. This winter, trash and recycling was delayed twice in one week due to scheduled holidays and winter storm events. Without the additional holiday delays we would have more flexible to pick up everyone's solid waste without going over into an additional week.
