- 1. Building Department Level service budget and staffing
- 2. Appeal Board Funds for notifications based upon appeals, advertising fees are reimbursed
- 3. Town Council Level Service. Mainly for MA Municipal Association dues
- 4. Town Administrator Addition of a deputy town administrator (2H '15). Half person staffing increase with a 2015 part-time retirement. Transition considerations to ensure seamless.
- 5. Finance Committee Funds for expenses and dues. Level service budget.
- 6. Comptroller Level service budget and staffing
- 7. Assessors Level service budget and staffing
- 8. Treasurer/Collector Level service budget and staffing
- 9. Legal Increases due to collective bargaining arbitration related expenses. All contracts are up for renewal.
- 10. Human Resources Healthcare provider change (~6% savings). Increases for medical exam costs (\$2K/exam). Level service budget and staffing.
- 11. Central Services Increase of ~5K from PY. ~100% due to increased postage costs.
- 12. Animal Control Level service budget and staffing. Service shared with Bellingham.
- 13. Memorial Day Flags for veterans cemetery plots
- 14. Cultural Council Level budget. Redistributed back via grants.
- 15. Debt 2006 & 2007 bonds refunded in Feb 2015. HS and library re-fi in late May. General debt within prop 2 ½ at ~3.1% of the General Fund budget (3.5% cap). Other than the HS current debt to be paid off by 2018. Further debt obligations TBD
- 16. Employee Benefits Flat OPEB from PY (policy is to increase by \$100k/yr. Other pressures. May revisit). Workers comp increase due to 3-yr rolling average. Unemployment expenses are down. Comp reserve for unsettle firefighters contract.
- 17. General Insurance insurance for property casualty and liability. Increase from PY due to a HS sprinkler malfunction.
