SUBCOMMITTEE REPORTS

⊗ Communications – (Bob, Alan, and Mary O'Neill)

Marlene volunteered the services of her husband Bob to work on the Museum brochure. Bob P. will email the latest draft files to her.

Mary Olsson has received many beautiful submissions for the contest to create a logo for the Museum. She presented those she had received. When all submissions have been received (some remain to be submitted), we will decide which is best. It is unlikely that this will be finalized before the Strawberry Festival next month (June).

Solution Document Preservation and Policies – (Alan, Connie, Del, and Eamon)

Del has begun working on writing a short procedure about using our new equipment. This will be useful for interns or anyone not familiar with it.

Alan has been working on filling gaps in our coverage of Franklin High School yearbooks.

 \rightarrow We should be on the list of recipients for Dean College year books.

 \rightarrow We need to state in our brochure, and on the web, which information we have available on microfilm, and that one can view this information by appointment. (We would schedule these appointments when we knew a Historical Commission member was hosting.)

It would be good to write a short procedure for using the new equipment, especially for interns who will use it.

 \rightarrow From last time: A proposed project – to scan some of the scrapbooks we have, create copies, then display the copies. Is this something we want to pursue? If so, who can coordinate this?

 \rightarrow Also from last time: From the FHS, we could borrow FHS yearbooks we are missing, and scan copies of them. Is this something we want to pursue? If so, who can coordinate this?

Del reported that Debbie had had Stella Jeon's interviews copied in duplicate onto DVD for the Museum. Duplicates are now in the Library Room; original VCR tapes and DVD copies are downstairs.

Internet connectivity at the Museum – Del had issued a work order to investigate it.

The Strawberry Stroll (Festival) will be held on Thurs. June 16th. We agreed to provide lemonade and perhaps strawberry themed cookies. We also discussed wearing some kind of rural attire or head gear.

We did not received any responses to our call to have people display their collections, so we will not have this event.

Debbie has been receiving a great deal of interest from people who want to lend us wedding dresses for our June display.

We would like to have some kind of Civil War event for the third Sunday of July (7/17). We need to coordinate with Alan on this. He is in touch with a reenactment group from N. Attleboro.

Marlene will be getting back in touch with her contacts in Boston about future grants.

Three classrooms of fifth graders plan to visit on Wednesday May 25th. Anyone can drop by to assist.

⊗ Intern Coordinators – Alan

Rob Lawson is in the process of selecting an intern.

Museum Displays - Del, Alice, Dianne, Colette

Debbie and Ron P. finished installing the Plexiglas covers for our display case drawers. They look great! We discussed inserting some kind of peg or screw in the back of each drawer so that the glass would stay inserted in the slot in the drawer's front plate. \rightarrow Who can do this?

Museum Operations - Del (inventory, requests), Alice (finances), Dianne

We approved the use of \$1008. from the Commssion's account to pay for the Plexiglas for the cabinet drawers.

The Town Controller notified Debbie that there is \$95. in a gift account that was donated on Barbara Smith's behalf.

(In general, if a purchase for the Museum is under a certain amount, we can simply purchase the materials at Staples (for example), then submit receipts to the Commission for reimbursement.)

We discussed again possible ways to prevent displayed pictures from curling. Marlene recommended that they be displayed on acid free boards and in sheeting that blocks out UV rays. Alan suggested scanning the originals, printing out copies, and displaying the copies. We also

Demolition Requests

We received a letter and supporting information from Jeff Nutting, by way of Building Commissioner David Roche, requesting approval to demolish the structures currently owned by the Town at 87 Grove St., site of the former NuStyle jewelry manufacturing facility. After revewing the information, the Commission approved the request. Bob will inform David Roche and Jeff Nutting in writing of this decision.

Research Requests

We received an information request about the Rail Trail effort. Alan will respond to Steve Sherlock who sent it to us.

Del is researching prior ownership of 31 Hayward St. It was built around 1900, and has housed many businesses since then. (One of the current tenants wanted to know.)

New Business

Debbie has been in touch with the owners of the shopping mall on E. Central St. They like the idea of the cupola.

Plans to expand the Horace Mann commemoration site to include the cupola from the Four Corners School: The Town will be examining the structural integrity of the cupola.

The Spanish gunboat gun from the Spanish American War will be reinstalled on the Town Common soon.
