## Presentation/Discussion:

Mr. Sullivan discussed with the Committee the site work progress. He noted that the rough grading of the new parking lot is 85% complete. Also, the grading of the new driveways behind the building is 65% complete. He also discussed the progress on the interior and exterior of the building. The roofing on the classroom wings is 96% complete. Exterior masonry is 10% complete and the courtyard masonry is 65% complete. The structural steel is 98% complete. They continue to work on interior masonry and stud wall framing of classrooms. Mr. Fennell noted that we are still on schedule. He also noted that the parking lot turnover looks good as well. Mr. Mercer noted that he will hold a public meeting in August to discuss the fall traffic pattern with the Community.

Mr. Fennell went through the change order log with the Committee.

Mr. Jordan and Mr. Valentine showed samples of the paint finishes and floor finishes to the Committee. Mr. Valentine noted that they went with a tone on tone palette.
