The Task Force will connect with the Chem-Free group to see how we can help to spread the word about donations and possibly provide some additional volunteer assistance.

Franklin Youth Initiative (FYI) Update (see FYI powerpoint) WOW. FYI Teacher Advisor and the FYI kids have been doing a great job! Last week, the kids were at the State House testifying in opposition of HB 1526, a bill that would decriminalize up to ½ ounce of marijuana. They did a fantastic job, commented the Chief, despite a very difficult committee that heard their testimony! The kids were thrilled with their work, and are looking forward to heading back to the Senate once the bill crosses over. The Mayor stated that he will send the FYI group a thank-you. Ms. Libby, Coalition Coordinator Traci Fowler, and three FYI students are currently continuing their advocacy and leadership training at the week-long National Youth Leadership Initiative conference in Washington DC. This is a CADCA event, and we are looking forward to hearing how it went. The FYI students are planning to present about their trip at our next Task Force meeting.

Data Collection Update – Evaluator, Katy Shea gave an update of our data collection efforts to date. So far, 5 key informant interviews are the in process of being conducted, and 2 focus groups are scheduled – one for youth and one for parents. This local data will be very useful in getting our Logic Models updated with current information.
