Meeting Notes:

**Building our Capacity for ADVOCACY!** It was great to have Tricia Lucas and Linda King present to our group. New Future's role is to help individuals realize their power to shape public policy and influence decision makers. Legislative Priorities for the 2012 Legislative Session include:

- HB 1521 New Futures opposes this bill, as it would expand the distribution of spirits (liquor) to grocery and convenience stores.
- HB 1610 New Futures opposes this bill, as it would lower the drinking age to 19 for military members.
- HB 1526 New Futures opposes this bill, as it proposes to decriminalize up to ½ ounce of marijuana.
- SB 286 New Futures supports this bill, as it creates a controlled drug prescription monitoring program.

It is EXTREMELY important for local citizens, especially youth and parents to get involved in advocacy at the state level. Elected officials are used to hearing from the paid lobbyists, but having "regular people" testify is very powerful.

The next Community Leadership Initiative, a 1-day Leadership Retreat, takes place on March 6, 2012 from 8:30am – 3:30pm, at the Common Man in Concord. A great lunch is provided! This is an important training for folks who are interested in learning more about the legislative process and how local citizens can be heard. A number of Task Force members expressed interest, and we will follow up with Linda to get them registered.

**December Meeting Follow-Up:** Katy Shea, our contracted evaluator with Community Health Institute (CHI) presented the draft Focus Group and Key Informant Interview questions to the group for review. We looked over the questions and discussed some logistics for getting in touch with key professionals in the community. Next steps will be to reach out to the people we identified to schedule the interviews. Traci will follow-up with parents and youth to get Focus Groups scheduled. We hope to have the interviews completed during late January/February.

Shannon is going to explain the Legislative priorities to the kids to see if/which bills they are most interested in and will connect with Traci. In addition, Traci, Shannon and 3 FYI students will be attending the National Youth Leadership Initiative (NYLI) in January! We are all very excited about this opportunity, and will have the students present on their trip when they return.
