Jason researched and found this video, and we agreed that it would be good for the group to watch it before making any decisions. The video is very informative and really emphasizes that student drug testing is NOT about punishment, but it is about being a deterrent for students. There are many steps in creating a student drug testing policy, and obviously a lot of upfront legwork is needed to make sure that it is successful. Training for school staff is a big piece, as well as contracting with a 'Licensed Medical Review Officer'.

### **Questions:**

(1) Pros/Cons: Do we want to pursue Student Drug Testing as part of our ATOD School Policy recommendations?

While we think this is something that would be really beneficial to our school, we do not know if the school is ready to implement such a major program. What are the school ATOD policies currently? Are they being enforced? They current policies are not comprehensive enough and seem to not be consistently enforced. It might be good to first talk about making the ATOD policies more comprehensive, and the next hurdle is HOW can we make sure they are enforced?

We have to get parent and community support if we are going to make any change in the current ATOD policy.

What about home drug testing kits for parents? Maybe this is something we can purchase and hand out to parents who are interested. Might be a good way to get the word out about drug testing. Would the school be willing to have these at the nurses' office?

(2) If so, what are our next steps? A meeting with the Superintendent would be a good first step. Traci will follow-up with Dr. Ward to see if she would be willing to watch the video, and then have a conversation about how we can start working on this.
