We then briefly gave some updates and had a short discussion about the ATOD School Policies.

ATOD Policy Discussion:

Seems that ATOD is only mentioned in Student Athlete Handbook – Student Handbook does not seem to reference anything about Drugs, although it does make a mention about Alcohol.

We are still in the process of gathering more research about specific schools that have something similar in place. Jason has collected A LOT of research, and this type of a policy does exist in numerous schools across the country.

The Governor's Prevention Task Force is apparently working on a statewide survey of schools re: their ATOD Policies, and are potentially creating a template for ATOD Policy that schools can use. Traci will find out more information about this. **This could be a great resource for our efforts.

Questions for further discussion:

- Price of drug testing kits? Seems that they can be as low as \$2/kit, and there may also be places that will donate the kits: http://www.notmykid.com
- What happens once it is found out that a child is using? Are there any resources available?
- How is "reasonable suspicion" defined?
- What about testing school faculty?
- What about the route of appeal?
