**Discussion:**

Currently there is an ordinance prohibiting the use of tobacco in the Cities Recreational facilities. With the City taking over the Bessie Rowell School and turning it into a community center, I would recommend adding the Bessie Rowell Community Center to the Use of Tobacco Ordinance for Parks and Beaches. This would keep all the city owned parks consistent with the ordinance and protect the safety, health and welfare of the general public.

**Fiscal Impact:** Proper signage would need to be purchased and posted which the Mayor's Drug Task Force has committed to purchase the signage needed.

**Alternatives:** Citizens will be allowed to use tobacco products at the new Community Center.

**AN AMENDMENT TO THE FRANKLIN MUNICIPAL CODE:**

In the Year of our Lord, Two Thousand Twelve;
