<u>Contingency Grant Line Activity:</u> The City has nothing new to report this month in the contingent grant line.

The Park Family Fun Day & Chicken BBQ fundraiser: is taking place on Friday, August 10th at Odell Park, 2pm – 6pm. Tickets Adult = \$10 Child = \$5 Family of 4 = \$25 Checks can be made out to: Odell Park Centennial Project (OPCP)

<u>Update on 73 Elkins Street demo:</u> The City is abating the asbestos on site 8/13/12 and coordinating the removal of the structure 8/14 thru 8/17. The municipal services department will then dress up the site.

Boys and Girls Club of America: On July 26th I was invited to attend a meeting with Councilor Dzujna and a group of citizens to discuss the possibility of creating a local Boys and Girls Club of America here in Franklin through a partnership/mentorship with the Laconia club. Representatives from the Boys and Girls club scheduled follow up meetings with Director Alpers to discuss training/mentoring opportunities needed to meet our most immediate need- after school programming. The group is looking to continue to meet to discuss the feasibility of a club here, discuss which age group would be the focus, the type of programming, get an idea of cost, the number volunteers that would be needed, and create a template budget for fundraising. Anyone in public that is interested in participating in this effort can contact me or Councilor Dzujna and we will put you in touch with the group. This group is the early stages of forming and is currently evaluating whether or not this project would be feasible. It seems fundraising (budget), volunteers, and site costs are some of the immediate questions that need to be answered.
