Council Presence at Elections.

With all Elections coming under closer scrutiny by the State of New Hampshire Attorney General's Office, they are visiting each polling place on election day to make sure that each of our Wards are in compliance with State and Federal Regulations.

At the Presidential Primary in January, the Attorney General's Office sited Ward 1 for non-compliance of item #10 (Election Officials Present) on the NH Attorney General's Office Polling Place Checklist. The letter states that this must be corrected prior to the next election. (see attached)

NH Constitution, Part 2, Article 32 requires that at least two "selectman" be present on Election Day. (see attached)

We were fortunate enough that they did not come to our polling places at the NH State Primary on September 11th. I anticipate a visit from the inspector at the General Election in November.

As long as we have at least two council members at each ward, this will satisfy the AG's Office. I am hopeful that you can work this very important day into your busy schedules.

The General Election is on Tuesday, November 6th from 8am – 7pm.

*Based on the inspection of your polling place at the 2012 Presidential Primary, the following items, with numbers corresponding to the checklist, must be addressed prior to the next election unless otherwise noted: 10 (selectmen).

It is because of your dedication and that of other election officials in your polling place that the elections in this State continue to be a model for other states to follow. We hope that the inspection of your polling place and this feedback letter will result in more efficient future elections.

[Art.] 32. [Biennial Meetings, How Warned, Governed, and Conducted; Return of Votes, etc.] The meetings for the choice of governor, council and senators, shall be warned by warrant from the selectmen, and governed by a moderator, who shall, in the presence of the selectmen (whose duty it shall be to attend) in open meeting, receive the votes of all the inhabitants of such towns and wards present, and qualified to vote for senators; and shall, in said meetings, in presence of the said selectmen, and of the town or city clerk, in said meetings, sort and count the said votes, and make a public declaration thereof, with the name of every person voted for, and the number of votes for each person; and the town or city clerk shall make a fair record of the same at large, in the town book, and shall make out a fair attested copy thereof, to be by him sealed up and directed to the secretary of state, within five days following the election, with a superscription expressing the purport there of.
