Subject: **Public Hearing for, and Adoption of, Proposed Ordinance 03-14**

Proposed Motion:

"I move that the Franklin City Council adopt Ordinance 03-14 and strike the sunset provision clause, and add it to the Franklin City Code. This Ordinance will enhance public safety by better regulating the passing and exchanging of items between pedestrians and the occupants of a motor vehicle."

Discussion:

The City Council scheduled a public hearing, held at the beginning of this Council meeting, on this proposed ordinance. As noted at the November meeting, this topic has been discussed by the Legislative Committee at two different meetings, and input has been provided by the Police Chief and the City Attorney.

In the opinion of the Legislative Committee, the adoption of this Ordinance will help to better provide for overall public safety. The inappropriate interaction between pedestrians and motor vehicles creates the potential for accidents and traffic congestion. The primary roadways in the City are all part of the state or federal highway system and promoting safe traffic patterns is paramount to the overall operation of this roadway network.

As mentioned in the November 4th CAR, the City Attorney, in his review of the draft Ordinance, suggested that the City Council consider the appropriateness of the sunset provision. He stated that if the Ordinance needed to be revoked in the future then a hearing on that action would be the best way to proceed. I would respectfully recommend that the sunset provision be stricken from the adoption of the Ordinance.

The members of the Legislative Committee voted unanimously to support the adoption of this Ordinance.

Alternatives:

The City Council can vote to not adopt the ordinance, and it could be taken up at a later date, or it can be dismissed entirely.

Ordinance 03-14

AN AMENDMENT TO THE FRANKLIN MUNICIPAL CODE:

In the Year of our Lord, Two Thousand Thirteen

Be it ordained by the City Council of the City of Franklin that a new Chapter be added to the Franklin City Code as follows:

Chapter 284-20.2 The Passing of Items to or from the Occupant of a Motor Vehicle on a Roadway.

- A. *Intent of Section.* This Section is intended to provide for the free flow of motor vehicle traffic on roadways in the City. The City Council finds that persons who distribute any item to, receive any item from or exchange any item with the occupant of a motor vehicle upon a roadway present a threat to the free and safe flow of motor vehicle traffic. By this Section, the City Council intends to promote the health, safety and welfare of the citizens traveling by vehicle in the City.
- B. *Definitions.* For purposes of this Section, the following definitions apply:
- 1) *Pass/Passing.* Distributing any item to, receiving any item from, or exchanging any item with the occupant of a motor vehicle that is located in the public way.
 - 2) *Public way.* All public roads or public parking areas open to motorized vehicles within the City. This definition excludes private roads and private property.
 - 3) *Item.* Any physical object including, but not limited to, money, literature, or sales flyers.
- C. *Prohibition on Roadways.* It shall be unlawful to violate any of the prohibitions set forth below in the City.
- 1) No person shall knowingly pass any item to, receive any item from, or exchange any item with the occupant of any motor vehicle when the vehicle is located in the public way.
 - 2) This Section shall not apply to the passing of any item with the occupant of a motor vehicle on private property.
 - 3) This Section shall not apply to any law enforcement officer acting in the scope of his/her official duty.
 - 4) This Section shall not apply to the passing of any item with the occupant of a motor vehicle located in the roadway in order to assist the occupant after a motor vehicle accident, with a disabled motor vehicle or where the occupant is experiencing a medical emergency.
 - 5) No pedestrian, or other person, standing or sitting at an intersection, stop light, or other similar location where traffic is temporarily or permanently stopped, shall approach the driver or passenger of any vehicle for the purposes of asking about, or seeking, the passing of any item to and/or from the pedestrian and the occupant of the vehicle.

- D. The only exemption to the provisions of paragraph "C" above is a "toll boot" fund raising drive operated by any department of the City or School, or another organization for whom permission has been granted by the Franklin Police Chief or a designee.
- E. *Sunset*: This Section shall automatically repeal on April 9, 2015, unless otherwise ratified by the City Council.
- F. *Penalty*: A person found in violation of this Section shall be guilty of a violation and may be fined not more than \$500.00.
- G. *Severability*: If any provision of this section is declared invalid or unconstitutional by any Court of competent jurisdiction, the remaining provisions shall be severable and shall continue in full force and effect.

Subject: Public Hearing for, and Adoption of, Proposed Ordinance 04-14

Proposed Motion:

"I move that the Franklin City Council adopt Ordinance 04-14 to better manage and regulate the use of City Property, and add it to the Franklin City Code."

Discussion:

The City Council scheduled a public hearing, held at the beginning of this Council meeting, on this proposed ordinance. As noted at the November meeting, this topic has been discussed by the Legislative Committee at two different meetings, and input has been provided by the Police Chief and the City Attorney.

In the opinion of the Legislative Committee, the adoption of this Ordinance will help to create improved management of City properties and better regulate its use in order to provide for public health, safety and welfare. As noted in the November 4, 2013 Council Action report for the scheduling of the public hearing. Camping has become a problem which consumes resources of the Franklin Fire Department's Code Enforcement Office and the Police Department. Public health and safety will be better protected by the proposed conditions and restrictions on camping on City property.

The members of the legislative Committee voted unanimously to support the adoption of this Ordinance.

Alternatives:

The City Council can vote to not adopt the ordinance, and it could be taken up at a later date, or it can be dismissed entirely.

Ordinance 04-14

AN AMENDMENT TO THE FRANKLIN MUNICIPAL CODE:

In the Year of our Lord, Two Thousand Thirteen

Be it ordained by the City Council of the City of Franklin that a new Chapter be added to the Franklin City Code as follows:

City Property

- A: In order to protect, and provide for, the health, safety, and welfare of the citizens of Franklin and all visitors to the City, The Franklin City Council hereby establishes provisions for the use of City-owned properties, and the restrictions for certain uses that might compromise the health, safety, and welfare of all persons.
- B: As the definition of "city property" encompasses many different types of land areas, rights-of-way, and structures, there already exists a variety of City Codes that addresses the use of these areas. The existing codes include, but are not limited to, the following Chapters:

101 Alcoholic Beverages	107 Animals	113 Bicycles

- C: In addition to the applicable City Codes, the City may adopt policies for the use of specific structures, parks, parking areas, sidewalks, or similar properties. The application and interpretation of the policies shall be carried out by the specific department responsible for the property. For certain proposed uses, the department head, in consultation with the City Manager, is permitted to apply some discretion to allow for certain uses that might not be included in the list of allowed uses but are determined to be consistent with, and similar to, the enumerated uses. All policies shall be adopted by the applicable committee of the City Council, or by the Council itself as deemed appropriate by the Committee.

- D: No camping or any overnight use of any City property is allowed unless it meets the following requirements:
- 1) The proposed use is being carried out by an organization which must have a recognized goal of community assistance, education, or other recognizable focus of community support. Eligible organizations may seek approval on a yearly, or a use-by-use, basis.
 - 2) Prior to approval by the appropriate City department [Parks and Recreation, Conservation, Municipal Services, etc.] the organization shall outline the proposed use and duration, and the number of individuals involved.
 - 3) Any City property used for any camping or overnight activities shall be cleaned after the activity and shall be left in its original condition. All trash or debris shall be removed from the property and disposed of properly.
 - 4) The appropriate Department Head, or the City Manager, retains the right to deny any camping or overnight use if a determination is made that the request did not adequately describe the planning or management of the activity, or the proposed use will not protect and provide for the general health, safety and welfare of the City.
