**Subject:** City Council to consider Resolution #10-13 for Twin Rivers Intergenerational Program (TRIP) Center CDBG Grant Appropriations and matching revenue

---

**Suggested Motions:**

1. Councilor moves:

*“I move that the Franklin City Council approves the adoption of Resolution #10-13 revising FY 13 appropriations and matching revenue for the TRIP CDBG grant by a roll call vote.”*

2. Mayor asks for a second, discussion, and calls the vote.

---

**Discussion:** As you are aware, the City of Franklin has been awarded (contingent on Federal funding of the CDBG program) another Community Development Block Grant in the amount of \$413,958 from the Community Development Finance Authority for renovations, equipment and furnishings to relocate the Twin Rivers Intergenerational Program (TRIP) to the Bessie Rowell Community Center. This is the final piece of the ongoing Bessie Rowell Community Center renovations project.

Therefore, to expend the funds through the City Budget adopted July 1, 2012 it is necessary to increase revenues: Federal Grants – CDBG TRIP center Acct No. 14-9-012-33110-421 – Four Hundred Thirteen Thousand Nine Hundred Thirty Eight Dollars (\$413,938)

And an increase in expenditure account Federal Grant Building – CDBG TRIP center account No. 14-9-012-40720-421 in the total amount Four Hundred Thirteen Thousand Nine Hundred Thirty Eight Dollars (\$413,938)

**Fiscal Impact:**

There is no impact to the taxes. This resolution increases both appropriation and grant revenue by the same amounts.

**A Resolution Relating to a Supplemental Appropriation for Fiscal Year 2013.**

**WHEREAS, the City Council of the City of Franklin has adopted a budget for Fiscal Year 2013 which began July 1, 2012, and;**

**WHEREAS, the City Council of the City of Franklin, New Hampshire has approved the Bessie Rowell Community Center design which includes the TRIP Center, and;**

**WHEREAS, the City Council of the City of Franklin acknowledges receipt of a Community Development Block Grant in the amount of \$413,938 from the Community Development Finance Authority for renovations, equipment and furnishings to relocate the TRIP Center to the Bessie Rowell Community Center, Now**

**THEREFORE BE IT RESOLVED, that at the scheduled meeting of the City Council on Monday, June 3, 2013, the City Council of the City of Franklin, New Hampshire does hereby approve the receipt of a community block development grant in the amount of \$413,938 from the Community Development Finance Authority and authorize an increase in revenues:**

**Federal Grants – CDBG TRIP Center Acct No. 14-9-012-33110-421 – Four Hundred Thirteen Thousand Nine Hundred Thirty Eight Dollars (\$413,938),**

**And an increase in expenditure account Federal Grant Building – CDBG TRIP Center Account No. 14-9-012-40720-421 in the total amount of Four Hundred Thirteen Thousand Nine Hundred Thirty Eight Dollars (\$413,938),**
