<u>Contingency Grant Line Activity:</u> The City received the following in the contingent grant line this month:

\$100 Gladys Marshall for Welfare \$500 Health Trust for Wellness grant

Fire Department activity: I have attached a copy of a press release from Chief LaChapelle related to activity during the month of January. Fire department employees were certainly put to the test during some extreme weather conditions. Once again Kudos to all for a job well done and amazing teamwork throughout the city!

Metrocast Franchise renewal: Metrocast negotiations with the cable consortium have come to a standstill. We are currently in a status quo state under the now expired ten year agreement (as of January 1st). It has been long year of earnest negotiations on both sides. The sticking point is the amount of funding Metrocast is offering to provide to each community for technology grants related to public access. These grants would allow us to create origination points in each community or update equipment. Once I receive a final document from Metrocast-I will need to schedule a non-public meeting with the Mayor & City Council to review/discuss the terms of the proposed agreement with the help of the consortium cable attorney (Kate Miller).

NARRATIVE:

Starting on January 19, 2014, area emergency responders have been inundated with significant incidents that have truly put our Mutual Aid System to the test.


- Sunday morning @ 4:40 am our activity started with a fire in the building at Mountain Ridge Healthcare on Baldwin St. in Franklin
 - 1st Alarm. Fire was out upon arrival however a smoke condition in the building.
 - No significant damage or displacement of residents
 - o Fire was caused by a malfunctioning microwave
 - Crews from Franklin and Tilton/Northfield handled this incident while Belmont covered the Franklin Fire Station
- Later Sunday evening Franklin crews assisted Tilton Northfield with a garage fire on Shaw Rd. in Northfield
 - This fire was suppressed by the residential sprinkler system.
- Yesterday @ 4:30 pm Franklin and Tilton/Northfield responded to a mobile home fire at 15 Hill Rd. in Franklin.
 - A 1st alarm was sounded. A complete loss of the mobile home due to smoke and fire damage. No civilian injuries. However, a Franklin Firefighter was cut by glass while venting a window.
 - Quick teamwork by Franklin Police Officers who closed the busy roadway.
 - o This cause of fire is believed to be electrical in nature
 - It should also be noted that the Franklin Ladder Truck was requested to Boscawen for an apartment house fire, however was unable to fill that request due to the Hill Rd. fire.
- Last night @ 7pm Tilton/Northfield and Franklin crews responded to a mobile home fire in Tilton.
 - This was a 2nd alarm for TNFD.

- ▼ This morning @ 1:05 am Franklin and Tilton/Northfield were toned to a fire in the building at 18 Auburn St. in Franklin
 - First arriving crews found fire hidden in the walls of the Victorian style residential building.
 - All eight residents were displaced from this multi-unit residence.
 - One FF was injured when they fell in the slippery driveway and was later seen by medical staff at FRH ER.
 - Once again...above and beyond TEAMWORK by Franklin Police Officers who used their cruisers to haul sand from the Highway Garage to the scene and sanded the driveway to prevent further injuries.
 - The cause of this fire is believed to be extension from the fireplace on the second floor.
- While operating at the building fire we received a call for an explosion near 24 Evergreen Ave.
 - The Franklin Ambulance and Mutual Aid Companies (Andover) arrived to find a pick-up truck fully involved with exposure to a building and an adjacent car.
 - NO INJURIES!

Just as our Municipal Services Department experienced last week with the ice and snow, our crews are worn down however still stand fast to respond. This extreme weather is rough on personnel, equipment and City services. Our Department is grateful for Mutual Aid and CITYWIDE TEAMWORK! Chief LaChapelle states "It is times like this that the strength of our Mutual Aid System shows its true value" He also states "Emergency crews will continue to operate with heightened caution during these adverse weather conditions as should our residence."

Properly working smoke detectors and sprinkler systems save lives!
