**In accordance with the provision of Chapter 31, Division 2 of the Franklin Municipal Code, notice is hereby given that the City of Franklin will hold Public Hearings on Monday, July 7, 2014 beginning at 6:06 p.m. in the Council Chambers, Franklin City Hall concerning: Resolution #01-15 concerning the appropriation of the FY15 Budget; Ordinance #01-15 concerning a \$5.00 fee for duplication of bills; Ordinance #02-15 concerning an increase in the sewer rate from \$6.13 to \$6.27 per 100 cubic feet; Ordinance #03-15 concerning an increase in the water rate from \$4.51 to \$5.26 per 100 cubic feet; Ordinance #04-15 concerning charges for delinquent water bills; and Ordinance #05-15 concerning an increase in the Veteran's Tax Credit from \$250 to \$300.**
