Contingency Grant Line Activity: The City received the following in the contingent grant line this month:

Franklin Mayor's Drug Task Force update: The task force has been busy! In May we had a booth at community day and took in 100 surveys. We hosted a lunch and learn on the Youth Risk Behavior Survey (YRBS) how to use and interpret this data. This survey is an anonymous survey completed by high school students every other year. The task force held our first Bow Wow ball to raise funds for the continued operations of the K9 program (netting about \$1435). The Mayor & Task force had an opportunity to host a meeting with US Senator Jeanne Shaheen, Michael Botticelli, Acting Director of the Office of National Drug Policy, and many other substance abuse prevention specialists and partners. The Franklin FYI students also attended this meeting and had the opportunity to share their thoughts on substance abuse with the group. (Check out the website for pictures). Lastly, May 29th the task force hosted a town hall meeting & dinner at the Bessie Rowell Community Center on the subject of underage drinking.
