## RESOLUTION #02-15

### A Resolution Relating to a Supplemental Appropriation for Fiscal Year 2015.

In the year of our Lord, Two Thousand Fourteen,

WHEREAS, the City Council of the City of Franklin has adopted a budget for Fiscal Year 2015 which began July 1, 2014, and;

WHEREAS, the City Council of the City of Franklin, New Hampshire recognizes that the school district estimates approximately \$260,000 in unassigned fund balance at June 30, 2014, and;

WHEREAS, the City Council of the City of Franklin would like to appropriate \$192,557.52 of the prior year unassigned fund balance in order to fund the purchase of copiers school wide as opposed to entering into a lease purchase agreement, and;

WHEREAS, the City Council of the City of Franklin recognizes that the outright purchase of the copiers will save the City a total of \$58,354 in interest and costs from a leasing program, Now

THEREFORE BE IT RESOLVED, that at the scheduled meeting of the City Council on Monday, October 6, 2014, the City Council of the City of Franklin, New Hampshire does hereby adopt resolution 02-15 and authorize an increase in revenues:

Appropriated Fund Balance - One Hundred Ninety Two Thousand Five Hundred Fifty Eight Dollars (\$192,558),

And an increase in expenditure account School District expenditures in the total amount of One Hundred Ninety Two Thousand Five Hundred Fifty Eight Dollars (\$192,558),

By a roll call vote.
