## FRANKLIN SAU WITHDRAWAL TIMELINE

- 7/20/15 Franklin Board votes to pursue withdrawal from SAU 18 and requests approval from the Franklin City Council to establish a Withdrawal Planning Committee.
- 8/3//15 Franklin City Council holds Public Hearing on the establishment of the Franklin SAU Withdrawal Planning Committee (FWPC)
- 8/24/15 Franklin City Council votes to establish a Franklin SAU Withdrawal Planning Committee (FWPC). *Special Meeting.*
- 10/5/15 FWPC completes preparation of proposed Withdrawal Plan. RSA 194-C: 2, I, b.
- 10/7/15 Proposed plan approved by a majority of FWPC members (not just majority in attendance when vote is taken). RSA 194-C:2, I, a, 8.
- 10/8/15 Post notice of 10/26/15 SAU 18 Public Hearing in Franklin and Hill. Notice of public hearing must be **posted** in all “*affected school districts*” at least two weeks in advance of public hearing. RSA 194-C:2, I, b, 1 & RSA 194-C:2, IV ,d.
- 10/9/15 Copy of proposed Plan submitted to “*several school districts*” (All SAU 18 school districts, Franklin and Hill) 14 days prior to submission to State Board. RSA 194-C:2, II, c & RSA 194-C:2, IV, d.
- 10/26/15 FWPC Public Hearing on the Withdrawal Plan.
- 10/27/15 Submit proposed Plan to State Board of Education. RSA 194-C:2, I, b, 2. & RSA 194-C: IV, c.
- 10/27/15-12/26/15 State Board of Education has up to 60 days to review (to determine if “*all requirements properly addressed*”) and make recommendation. No veto. RSA 194-C: 2, VI, d, & RSA 194-C:2, III, d. *Hearing dates 11/18/15 & 12/14/15.*
- 12/4/15 Post Notice of 12/14/15 City Council Public Hearing. Published in Newspaper also.
- 12/14/15 Franklin City Council Public Hearing on the Withdrawal Plan. *Special Meeting.*
- 1/4/16 Franklin City Council votes to approve Withdrawal Plan effective July 1, 2016. If petitioned by 100 voters and the City Charter permits, question is placed on the Official Ballot for next regular Election. RSA 194-C: 2, I, a, (2) (A).
