

**ORDINANCE # 04-16**

**AN AMENDMENT TO THE FRANKLIN MUNICIPAL CODE:**

**In the Year of our Lord, Two Thousand Fifteen;**

**Be it ordained by the City Council of the City of Franklin that the Franklin Municipal Code, Chapter 284, Vehicles and Traffic, be changed as follows:**

**Add:**

**A new section to the Franklin City Code creating "Article VII, Section 284-38, Public Schools"**

**Subsequent to creating this section add the following sections:**

**A. One Way Streets, Passages, Access and Egresses**

High School Traffic Pattern	Beginning at Daniell Point Rd. proceeding to Central St.	Westerly around the rear of the school towards the West Parking Lot then Northerly exiting onto Central St.
