Approved Energy Project Funding Interest Rate Change

Recommendation:

I recommend the Council approves the new interest rate of 3.97% (from 3.19%) for the lease purchase through Municipal Leasing Consultants for the Energy project.

Discussion:

On February 3, 2014, the City Council adopted resolution 07-14 approving an energy performance contract with Energy Efficient Investments, Inc., authorizing the City to enter into a lease purchase agreement with Municipal Leasing Consultants, and appropriating the project in the FY14 budget. As most of the Council is aware, the City was unable to secure financing due to tardy financial statement reporting. The Council and the School Board have worked together throughout the year to address the reporting issues. Recently, the City was able to issue FY12 final financials and FY13 draft financials making leasing an option again through Municipal Leasing Consultants. However, due to the time delay between now and the initial approval coupled with our untimely financial reporting, the interest rate has increased to 3.97% (from 3.19% last February). In addition, the FY14

budget appropriation for this project has lapsed so this resolution also re-appropriates the project in the FY15 budget.

Concurrences:

The Council approved the energy performance contract and the funding mechanism through resolution 07-14 adopted February 3, 2014.

Fiscal Impact:

The interest rate increase equates to \$15,239 over the life of the lease (12 years).

Alternatives:

The project would not move forward without this interest rate increase approval or the leasing company changing the interest rate to at least 3.19 % as originally approved.

WHEREAS, the City Council of the City of Franklin has adopted a budget for Fiscal Year 2015 which began July 1, 2014, and;

WHEREAS, the City Council of the City of Franklin has adopted Resolution 07-14 approving an Energy Performance Contract with Energy Efficient Investments, Inc. addressing energy related and capital concerns in several City owned buildings including City Hall, Proulx Center, Bessie Rowell Community Center, Highway Garage and Police Station, and;
