Subject:

Franklin Mayor's Drug task force has been awarded their second Drug Free Communities Grant of \$625,000 (\$125,000 per year for the next five years)

> Recommended Motion: "I move the Franklin City Council adopt resolution #05-16, appropriating \$93,750 from the Drug Free communities grant funds on behalf of the Franklin Mayor's Drug Task Force".

#### Discussion:

The Executive Office of the President, Office of National Drug Control Policy (ONDCP), and the Department of Health and Human Services (DHHS), Substance Abuse and Mental Health Services Administration (SAMHSA), Center for Substance Abuse Prevention (CSAP) has awarded the Franklin Mayor's Drug Task **their second five year** grant starting (FY) 2015 through the Drug Free Communities Support Program (DFC). The purpose of this program is to establish and strengthen collaboration to support the efforts of community coalitions working to prevent and reduce substance use among youth.

The City of Franklin is fiscal agent for the Franklin mayor's drug task force. This award is for up to \$125,000 per year for five additional years.

This funding is for coalitions which represent different sectors of the community (clergy, school, government, police, citizens, youth etc). The purpose of the grant is to reduce substance use among youth and over time to reduce use among adults by addressing the factors in a community that increase the risk of substance abuse. Using environmental strategies like limiting access to substances and changing norms in a community. (a few examples K2 ordinance, prescription take back box at Police dept, youth empowerment-FYI groups)

This grant requires a 125% matching amount thru the 8<sup>th</sup> year and 150% in years 9 & 10 that can be completely in-kind services. In-kind donation/hours include crediting the coalition for the time of the members serving, and participating, the meeting space, items donated, time of members at things like open houses or fund raisers, and the work of the school resource officer and for my time to oversee the project etc. We have had no problem documenting more than enough in-kind contribution to this grant.

A Resolution Relating to a Supplemental Appropriation for Fiscal Year 2016.

In the year of our Lord, Two Thousand Fifteen,

WHEREAS, the City Council of the City of Franklin has adopted a budget for Fiscal Year 2016 which began July 1, 2015, and;

WHEREAS, the City Council of the City of Franklin, New Hampshire recognized the need to address substance use and abuse within the community and established the Mayor's Drug Task Force in FY11 with 5 year grant funding from the federal government's Drug Free Communities Support Program, and;

WHEREAS, the City Council of the City of Franklin, New Hampshire recently supported the grant application for another 5 years of funding from the same grantor as the current grant ends on September 29, 2015, and;

WHEREAS, the City Council of the City of Franklin acknowledges receipt of the federal grant for another 5 years and wishes to appropriate the grant funding applicable to the remaining of current fiscal year, Now

THEREFORE BE IT RESOLVED that at the scheduled meeting of the City Council on Monday, October 5, 2015 the City Council of the City of Franklin, New Hampshire does hereby adopt resolution 05-16 accepting the 5 year federal grant in the total amount of \$625,000 and authorizing an increase in FY16 revenues:
