I. CALL TO ORDER 6:20 pm – Basement meeting room at the Fremont Town Hall.

Present: Selectmen Annmarie Scribner and Brett Hunter; Town Administrator Heidi Carlson. All rose for the Pledge of Allegiance.

Selectmen reviewed the mail folder and draft Town Reports.

Selectman St Germain called in by phone to the meeting at 6:25 pm and the Board discussed the newsletter publication. There was discussion about the article submitted by the Fremont School Board, which is a partial Warrant Article Narrative. Selectmen felt that it does not meet the criteria for the newsletter in that it is not a complete document (does not address all warrant articles). Motion was made by Hunter that the document as submitted does not meet the criteria to be part of the Newsletter and to suggest that the School Board should send this out on their own. Scribner seconded and the vote was approved 2-0. Selectmen also felt that there should only be one statement at the end of the document urging residents to attend Deliberative Session, not at each article.
