VI. OLD BUSINESS

1. After all reviews were completed, motion was made by Cordes to enter a contract with Vision Government Solutions for the 2015 Full Statistical Revaluation and have Chairman Hunter sign the contract on behalf of the Board. Holmes Sr seconded and the vote was unanimously approved 3-0. Hunter signed two originals of the contract with Cordes as a witness. They will be forwarded to Vision, with one fully executed to be returned to the Town.

2. The Board set aside an hour at the beginning of next week's meeting for Policy Review. All members will bring current drafts and their notes on each policy for discussion.

3. An emailed draft of the 2013 audit report was received this evening by the Town Administrator. It was forwarded to all Board members to review. The Board discussed at length the reason for the delay in receiving the report and drafted a letter to be reviewed and signed next week asking about the delays.

4. Selectmen discussed Deliberative Session and preparation for the Warrant Articles. It was decided that copies of the Warrant Article Narrative, budget, and default budget would be made available for the meeting.

VII. NEW BUSINESS

1. Selectmen reviewed the payroll \$19,592.07 and accounts payable manifest \$64,309.38 dated 30 January 2015. Motion was made by Cordes to approve the manifests. Holmes Sr seconded and the vote was unanimously approved 3-0.

2. Selectmen reviewed bills and invoices for payment.

3. Selectmen reviewed the folder of incoming correspondence. There were two letters regarding snow plow concerns, one from a Riverside Drive resident whose mailbox post was hit by a bus today, and one from a Nathaniel Brown Drive resident concerned about the cul-de-sac and conduct of a plow driver. The Board will follow-up with Mark Pitkin and get back to the residents. This led to discussion of a code of conduct for employees and contractors.

It was agreed by all that this week's blizzard presented extraordinary conditions. Several compliments were also received about the snow removal!

4. Selectmen reviewed an Excavation Tax Warrant \$36.00 for parcel 05-039.001 owned by Mark and Laurie Trostle Pitkin. Motion was made by Cordes and seconded by Holmes Sr to approve the warrant. The vote was unanimously approved 3-0.

5. Selectmen reviewed a Yield Tax Warrant \$293.12 for parcel 05-039.001 owned by Mark and Laurie Trostle Pitkin. Motion was made by Cordes and seconded by Holmes Sr to approve the warrant. The vote was unanimously approved 3-0.
