III. LIAISON REPORTS

01/19/2016 Energy Committee – Cordes reported that the Committee met and worked on the Town Report and reviewed the Master Plan Energy Chapter for the Planning Board; and that he is waiting to hear back from the solar representative relative to some questions.

01/20/2016 Planning Board – Holmes Sr reported that they had a work session. Three of the Board members are going to work on updates to the Sign Ordinance in response to Supreme Court rulings, and they continue to work on the Galloway Site Plan.

01/21/2016 Selectmen attended a training meeting at Pinkerton Academy, put on the by the NH Secretary of State's Office. The training covered up to date laws for polling places, recording of votes, and focused on the voter ID law and how to track blanks, double votes, write-ins etc.

Selectmen stated that it is very good for voters to bring their ID and Janvrin added that if you come to the polls without an ID, you will need to fill out a form and will also need to have your photo taken.

IV. APPROVAL OF MINUTES

Janvrin noted that item 2 under Old Business of the minutes for 19 January 2016 was missing "moved" in the motion to change the meeting date for this week. Motion was made by Holmes Sr to approve the minutes of 19 January 2016 as amended. Janvrin seconded and the vote was approved 3-0.

V. SCHEDULED AGENDA ITEMS

7:00 pm Public Input / Department Heads

At 7:15 pm FCTV Coordinator Bruce White met with the Board to introduce Alex Coulombe who is a SRHS student in the media programs and would like to be an FCTV Volunteer, and once trained, become an employee to help with broadcasting. Selectmen thanked them both for their work, and Coulombe explained he has done a meeting already with White, and is in the studio for tonight's meeting as well. He has the Town's employment paperwork to begin filling it out.

Both were thanked for their time and they left the meeting at 7:30 pm.

VI. OLD BUSINESS

1. Members did a final review of the Selectmen's Town Report which has some information added about recycling. Members discussed the Town's recycling average which is a little better than 20%. Janvrin moved to approve the final draft of the Board's annual report. Holmes Sr seconded and the vote was approved 3-0.

2. Policy Review – Pending completion of Deliberative Session next week. The Board asked to set aside time on the agenda for Fraud and Investment Policies on Thursday February 11, and the Personnel Policy on Thursday February 18.

VII. NEW BUSINESS

1. Selectmen reviewed the payroll manifest \$20,738.53 and accounts payable manifest \$48,432.86 for the current week dated 29 January 2016. Janvrin moved to approve the accounts payable manifest of \$48,432.86. Cordes seconded and the vote was approved 2-0-1 with Holmes Sr abstaining. Janvrin then moved to approve the payroll warrant of \$20,738.53. Cordes seconded and the vote was approved 2-0-1 with Holmes Sr abstaining.

2. Selectmen reviewed some old photographs for the Town Report cover, and reviewed some other reports with additional explanations provided (Comparative Statement of Appropriations and Expenditures); as well as the Appreciation and Dedication information.

3. Selectmen reviewed the folder of incoming correspondence. Board members then reviewed and signed outgoing correspondence to Dr Ballestero, Director of the UNH Stormwater Center in support of the Collaborative project to continue with WISE, with a project entitled "Watershed-Scale Economic, Social and Technical Understanding Necessary to Achieve Water Quality Goals."

4. Selectmen reviewed FCTV Manifest #2016-01 in the amount of 1,786.00 for all of the equipment in PO Cable RF 2015-006 to purchase microphones, mixer and accessories for the off-site broadcasting setup. Holmes Sr moved to approve the manifest. Janvrin seconded and the vote was unanimously approved 3-0.

5. Selectmen reviewed FCTV Manifest #2016-02 in the amount of \$204.54 for payroll costs for January 2016, being reimbursed to the General Fund. Motion was made by Janvrin to approve the manifest. Holmes Sr seconded and the vote was approved 3-0.

6. Selectmen reviewed a request from the Tuck Woods Homeowners Association to use the Town Hall on Saturday March 19, 2016 from 9:00 am to 12 noon for their annual meeting. Holmes Sr moved to approve the use with the usual \$25 fee. Janvrin seconded and the vote was approved 3-0. The Board said that the fee is to be charged in all buildings for similar uses. It is a nominal fee to cover lights and heat for time the building would not normally be in use.

7. Selectmen reviewed an Intent to Cut for parcel 05-011 on Shirkin Road. The landowner has also advised they are creating a landing near the roadside to do process some of the cordwood at the site. Holmes said he had a conversation with the logger this week and did not believe there were to be any chips, so the Board asked that this be clarified before final processing of the form.

VIII. WORKS IN PROGRESS

1. Town Reports – Some Town officers continue to work on their Annual reports. There are only a few days left until the book needs to go to print.

2. Planner Theresa Walker reported today that NH HSEM staff forwarded the final draft of the update to Fremont's Natural Hazard Mitigation Plan to FEMA last week. She will get back in touch with the Town as soon as she receives FEMA's feedback.

IX. NON-PUBLIC SESSION NH RSA 91-A

At 8:00 Janvrin moved to enter non-public session pursuant to NH RSA 91-A:3 II (c) to discuss a personnel matter. Holmes Sr seconded and the roll call vote was approved 3-0; Cordes – yes; Holmes Sr – yes; Janvrin – yes.

At 8:20 pm motion was made by Holmes Sr to return to public session. Janvrin seconded and the vote was unanimously approved.

At 8:20 pm Moderator Michael Rydeen joined the meeting to review the 2016 Warrant with the Board in preparation for Deliberative Session.

The Warrant was reviewed. Rydeen said that he will expect the Budget Committee to move and have the first 10 minutes of discussion on the Town Budget, followed by the Selectmen and he suggested that highlights of the budget be reviewed for voters.

There was discussion about the other articles and that the Selectmen should plan to move and second each article, and present, with Department Heads or Committees, information on any articles and answer any questions.

Richard Butler walked into the meeting at 8:30 pm and left off Town Report material.

Rydeen said that Selectmen should motion to restrict reconsideration on articles about every three or so articles.

Rydeen said he is meeting with election workers on Friday February 5 in preparation for the Primary.

Rydeen then discussed some potential pending legislation regarding petition warrant articles, as well as a proposal to change polling hours.

Rydeen left the meeting at 8:40 pm

Holmes moved to approve the UNH Stormwater letter that had been retrieved from upstairs. Janvrin seconded and the vote was approved 3-0.

The next regular Board meeting will be a work session, to be held on Thursday February 4, 2016 at 6:30 pm.

IX. ADJOURNMENT – by 9:00 pm

With no further business to come before the Board, motion was made by Janvrin to adjourn the meeting at 8:50 pm. Holmes Sr seconded and the vote was approved 3-0.
