

FREMONT PLANNING BOARD December 17, 2014 Meeting Minutes

Present: Chairman Roger Barham, Vice-Chairman John (Jack) Karcz, Member Jack Downing, Selectmen Brett Hunter, Alts. Phillip Coombs and Tom O'Brien, Building Official Bob Meade, interim RPC Circuit Rider Glenn Coppleman, and Land Use AA/Recording Secretary Meredith Bolduc.

Mr. Barham opened the meeting at 7:00 pm.

At the August 7, 2013 meeting Mr. Barham designated Alt. Coombs to fill a vacancy on the Board until the Board of Selectmen fills the vacancy, as allowed by RSA 673:12, III. This designation remains in effect.

MINUTES

Mr. Downing made the motion to approve the minutes of the December 3, 2014 meeting as written. Motion seconded by Mr. Karcz with unanimous favorable vote.

BEEDE SPAULDING

Map 3 Lot 056

The Board received a copy of a December 5, 2014 invoice #855795 from Stantec in the amount of \$396.50 Spaulding Road subdivision construction monitoring and a correspondence from Town Administrator Heidi Carlson to Treasurer Kimberly Dunbar relative to withdrawal of \$396.50 from the Beede Spaulding escrow account to cover the invoice.

BUILDING INSPECTOR

Mr. Meade reported:

67 Gristmill Road: The Mortgage company thinks the house, which is already built, is too close to the road and to the wetlands. He needs the surveyor to furnish a foundation certificate.

Sheds: It has come to his attention that here have been sheds constructed at residences on Main Street, South Rd and Victoria Farm Road without permits. The owners will be contacted.

Thunder Road: Dan Perry has submitted septic plans for a lot on Thunder Road.

Spaulding Road: Paul Langdon is bringing in plans for 2 houses on Spaulding Road.

Ellis School: In a flyer issued by the Ellis School there are reports of several upgrades having been completed to the school. Prior to the renovations being done Mr. Meade told Scott Brown (the custodian) that permits were needed for the work, but there were no permits taken out.

JACOB'S COVE Map 1 lot 098-1

Present: Owner/developer Jacob Donigian

At 7:30 pm Mr. Donigian met with the Board to discuss a reduction in the Jacob's Cove road bond.

The Board reviewed Dan Tatem's (Stantec) October 16, 2014 surety recommendation for Jacob's Cove. This included a table of estimates for the entire project (\$780,248.80) and a table of estimates for work to be completed (\$325,832.26.) Mr. Donigian said there is another updated estimate, but the Board did not have a copy of that to review.

Mr. Donigian said he got rid of 2 ponds that were on the property, but he did not have the calculations report from Bob Moynihan for the water drainage information. He said the ponds were located on the approved plans.

After some discussion Mr. Barham said the revised bond amount would be the amount that Stantec is proposing or 20% of the original bond amount, whichever is greater, and it would remain at that figure for the duration of the project and for the 2 year maintenance bond period after the road is approved.

Mr. Donigian said he will call Mr. Tatem and talk to Mr. Hatch to get the final figures.

Mr. Donigian asked if he could get rid of the school bus shelter that is on the plan. It was noted that anything that is on the approved plan needs to remain unless he amends the plan.

Mr. Donigian left the meeting at 7:55 pm.

Mr. Kohlhofer joined the meeting at 7:55 pm.

There was further conversation relative to whether a school bus would go into the project to pick up children. Mr. Kohlhofer said it would depend on the age of the children and if they were grade school or high school.

Mr. Barham said he will review the approved Jacob's Cove plan for what was approved.
