I. CONTINUED APPLICATIONS

Public Hearing continuation – Galloway / Seacoast Farms Site at parcel 05-035 located on Shirkin Road, Mr. Barham stated that there was a request from the applicant to continue this Public Hearing to Wednesday March 2, 2016. It sounded like Mr. Suprenant would have the fill removed before then – he will be in to discuss a plan to be in compliance with a home occupancy.
