#### **MINUTES**:

- Fred Bell County Weed Management Plan due for revision needs to be done by July, plan to have it done when the new weed list comes, April or May

#### **OLD BUSINESS:**

• Gravel Pit in Weed Management Plan – staff recommends imputing a statement that says "\*Be aware that gravel sources and topsoil may contain noxious weed seeds; therefore, we recommend using a source that is actively controlling noxious weeds on their property, consistent with an approved Weed Management Plan."

### **PUBLIC COMMENT:**

- Jane Mangold Extension Noxious Weed Specialist—Medusahead found in North Western Montana –
  annual invasive grass. Located in Sanders County on Salish Kootenia tribal lands. The county and tribe
  are working together. Infestation is about 80 acres. Same growth form as cheat grass. Has very high
  silica content, low palatability very poor forage, creates thick layer of thatch. Best management
  practice is prescribed burn, herbicide application(Plateau) and revegitation. Photos from Oregon
  infestation presented.
- Marcie Murnion Purchased 5 units in the Market Place building in Manhattan. The goal is to rent out kitchen in the facility and other facilities to have a rent free location. Purchased city lot used the help an

Americorp person to help develop an outdoor facility. Plan is to reduce Conservation District presence in the small acreage arena. Currently envision a full time position in the District for an education/resource person cooperating with Extension and NRCS. Conservation District is currently one of 3 finalists for a national grant for Conservation Districts

• Emily Lockard – Master Gardener class has started. Beef producers luncheon was held and the banquet is coming up. Crop school is Feb 19 at Headwaters (agenda available online). Greenhouse seminar - March 6. The search is underway for a new 4H agent

- > John Enforcement legal request reply from Erin Arnold
  - We are able to continue in the spring the enforcement of a complaint that begins in the fall
  - If a subdivision violates a WMP, the subdivision cannot be considered immediately in violation. The enforcement process must be followed in its entirety.
- The Enforcement Reserve account has been approved and set up
- ➤ Rush Skeleton Beaverhead County has a population in the Black Tail area. Infested by a sheep population moved from Washington State. Cooperate effort will take place for treatment.
