# Meeting Minutes March 14<sup>th</sup>, 2012 Town Hall 7pm, Basement Meeting Room

{Chairperson Waters moves order of business. Old Business is first}

Old Business: Meeting Opens at 7:05pm.

1. Chairperson Waters – Introduction to 4 True Lane owners "Owners."

Owners – Provide to Trust a copy of Kelly and Company's cost proposal for floor repair, floor installation and paint work. State a balance of \$1,250 is due to Kelly and Company for painting and deck repair.

Chairperson Waters – Requests Owners to provide billing from Kelly and Company outlining the \$1,250 due. Questions if any other balances are due for repair of the property.

AHT Agent Snyder – Reads invoice #9185 from Kelly and Company for repair and replacement of kitchen flooring.

AHT Agent Snyder – States one item remains on the voucher list and reads Invoice # 90755 from Koppleman and Paige for \$682.50.

Owners – Question sale date of property.

Member Nelson – States the listing date of the property will be established next week now that the listing agency, the THA, has a signed sales agreement.

Owners – Ask what the listing price may be? Close to \$202,500? States they are concerned about the closing date due to letters they are receiving from various banks. One letter was a notice of foreclosure.

Member Surface – Instructs AHT Agent Snyder to send a copy of the signed sales agreement to the Owners. (A hard copy of the agreement is given to the Owners). States that the signed agreement should be provided to the bank claiming foreclosure.

Member Nelson – Distributes Consumer Price Index (CPI). States we believe the sales number for the property will be close to \$202,500.
