Mr. Gerraughty: If the two units are built at Turning Leaf would the Trust be able to purchase? Is this something that needs to be determined by DHCD?

Mr. Nelson: The deed rider gives the Trust jurisdiction on the property.

2. Concerns of a Trustee regarding improvements needed at Trestle Way.

Mr. Nelson: I was contacted by Diane at Trestle Way regarding assistance in the purchase of a handicap ramp.

Ms. Drinan: We have a need for a universal ramp to the unit of one of our residents who is no using a walker. I am asking the Trust to funds to pay for the ramp. This ramp is portable so it may be moved to other units when needed.
