Citizens Petition for library project: John Anderson and John Sayre-Scibona explained the problems the library construction has been running into. The project has gone out twice to bid already and the bids came back high. It is presently out a third time and bids are due back in April 2006. They explained the specific changes made for each time the project went out to bid. The library project must stay within general specific scheme for the Mass State library board to continue to approve of this project and therefore still receive the grant money. The FinCom is concerned about the "lack" of fundraising to date and is there any constraint on fundraising. The only answer we received was that it is difficult to fundraise when the project is unsure.

**Fire Department budget review**: Jeff Manning presented the board with a detailed breakout for the fire dept. He reviewed item line by line. The department is looking to add full time employees. Robin stated that this should be done through the personnel board first. She also informed them that the personnel board was meeting on Wednesday, March 22<sup>nd</sup>. Two questions were raised, one concerning revenue that the fire department brought in and two if adding full time employees would reduce the home owners insurance rate for Georgetown. First, the dept brings in about \$5,000 yearly which goes back into the general fund. Secondly, John Durkee would talk to the insurance underwriters to see if having full time firemen could possibly be a factor in determining our rate for home owners insurance.
