Millennium

Mr. Moultrie states the concerns of the applicants and the Board with the Millennium inspections.

Mr. McGrath states that he has two correspondences dated December 10, 2004 stating that there was minimal work being done at some of the sites. Mrs. Tolman states that her concerns about her driveway being a hill. Mrs. Tolman gives her plan to the Board.
