Mr. Spicer gives the history of the project to the Planning Board and shows new changes to the plans. The proposal is now for 14 lots which creates more Open Space and will include 1 affordable housing unit.

Mr. Carter asks what Conservation is going to think about the new plan.

Mr. Spicer states that they are not going to get any closer than they were to the wetlands.

Mr. Holloway states that he represents the neighbors on True Lane and states that he would like True Lane only to be used for an emergency.

Mrs. Seaboyer states that the East Main St. exit is very dangerous. She states her concerns with the traffic flow on East Main St. Mrs. Seaboyer says the new development should use True Lane only.

Mr. Moultrie states that the access from East Main St. is an entrance only.

Mrs. Endicott states her concerns about how close the houses are to her horse barn.

Mr. Moultrie asks what she suggests.

Mrs. Endicott states that she would like the houses shifted toward the True Lane neighborhood.

Mrs. Freihofer states her concerns about the horse farm and The Meadows.

Mr. Natto states his safety concerns about the access road.

Mr. Moultrie asks Mr. Graham to look closer at the Traffic Study.

Mr. Hoover asks if the Board can hire an independent review for a traffic study.

Mr. Graham states that he can give Mrs. Buck a list of names for people to do the independent Traffic Study.

Mr. Hoover states that he would like a summery at the end of the traffic report that addresses specifically this project. Mr. Hoover states that he likes the reduction in lots. He explains to the Horse Farm people how people who own the land have the right to develop on his or her land according to the law.

Mr. Carter states that he agrees with Mr. Hoover.

Mr. Hoover states that he would like to address the issues that the Horse Farm people have. He states that the people that would potentially purchase these houses would be aware of what they are moving in to.

Mr. Holloway asks the Board to include the documents that they here submitted regarding traffic to the independent Traffic Study personnel.
