- 2. Title Search: Got referral to law firm for title work. JW will talk to KOD for additional recommendation.
- 3. National Grid meeting:
  - a. Representatives from Topsfield, Boxford, Georgetown and Newbury along with KOD met with National Grid at their offices.
  - b. NG has agreed to give Georgetown a license and expects to deliver it next week.
  - c. Each town is negotiating a separate license agreement.
  - d. Plan for Phase 1 will be restricted to mowing, trimming and use.
  - e. Implementation of Phase 1 plan is subject to completion of all permitting.
  - f. Any additional changes will be part of Phase 2 and will require an amendment to the license.
- 4. MVMPO email:
  - a. Communication from Betsy Goodrich. TIP for 2013-2016 has been amended and a new draft has been issued with additional funding for eligible projects.
  - b. Rec Path will submit proposal for funding of the northern half of the Georgetown trail.
  - c. HS will be attending the monthly meetings.
- 5. ConCom: HS will meet with Steve Przyjemski, conservation agent, to discuss next steps for proceeding on RDA.
- 6. Motion was made by JW and seconded by BH that we invite FST to the next meeting for consultation services on an hourly basis. Motion was unanimously approved.
