Article 30: Gift of land Parcel F, 172 East Main Street (ATM15-34)

Mr. Egenberg stated that the board has received calls from the Water Department and Park & Rec concerning this gift of land to the Conservation Commission. He stated concerns were for a possible water loop and greenway. Mr. Farrell stated that none of these things would be precluded by ConCom. I move to see if the Town will vote to authorize the Board of Selectmen to accept, for recreation purposes, a gift of land shown as "Parcel F, having an area of 14.635 acres, on a plan entitled: "Definitive Plan, Turning Leaf, Georgetown, Ma.", dated Oct. 10, 2013, and recorded with the Essex South Registry of Deeds in Plan Book 445, as Plan 49, and to enter into all agreements and take all related actions necessary or appropriate to carry out this acquisition.

The board agreed on the motion.
