#### **BOARD BUSINESS**

Town Administrators contract renewal

Mr. Trapani asked if the board was ready to sign the Town Administrator's renewal contract. Mr. Dawes asked for a change in Sec. 3 B. for the words "agrees to" to be replaced with "may" and after Employee's salary in the same section to add "as noted in Section 3 A." and to delete wording after that "based on an agreed upon economic...".

Discussion on wording in Sec. 3 B.

Mr. Surface asked if Mr. Farrell will receive the compensation in Sec. 7 B. Mr. Farrell stated that he will and in May will be able to do a line item transfer.

Mr. Surface <u>moved</u> to approve the contract renewal for *Michael Farrell, Town Administrator* with the changes in Section 3 B as noted from *July 1, 2016 to June 30, 2019*. Mr. Dawes seconded the motion.

Mr. Dawes stated that the board will perform a review in January.

The motion was approved by a 3-1 vote.

Chief Cudmore stated that he was present for the Mutual Aid Agreement. He stated that it did not require a vote by the board just the signature of the Chair of the Board. He stated that he will have to return with a new agreement after a new chair is elected.

Local Initiative Program Application for Local Action Units-Turning Leaf

Mr. Trapani stated that they have the Local Initiative Program Application for units that are a part of the Turning Leaf Subdivision Affordable Housing component.

Discussion on units and the sustainability of units with the allowable income levels.

Mr. Surface stated that Mr. Trapani's term will end after the election and a Selectmen will have to be appointed to fill the position.

Mr. Fowler stated that he looked at an affordable housing project in Boxford with Paul Nelson and that the town should look at the project as it falls under the towns Housing Production Plan.

Mr. Surface <u>moved</u> to accept and authorize the Chairman to sign the *Local Initiative Program*Application For Local Action Units-Turning Leaf - 44 Searle Street and Lot 19 Turning Leaf

Subdivision. Mr. Dawes seconded the motion and the motion was approved by a unanimous vote.

Financial Forecast Study Contract

Mr. Farrell stated that the DOR read our plan to join the Community Compact program and have agreed to give the town the full \$18,000 for the study. He stated that he needs a vote from the board to authorize Mr. Farrell to sign the study.

Mr. Surface <u>moved</u> to authorize Mr. Farrell, Town Administrator to sign the *Financial Forecast Study* contract with Mark D. Abrahams, CPA. Mr. Fowler seconded the motion.

Mr. Fowler stated that they will be working with the financial staff.

The motion was approved by a unanimous vote.

Mr. Fowler stated that he would read the motion for the Whittier Stab Fund.
