WHEREAS, The Town Board desires to appoint Mr. Aragosa to the vacancy and Mr. Aragosa is willing to accept the position of Receiver of Taxes as a part-time position at an hourly rate of \$30.00 per hour, without benefits, with total compensation not to exceed \$30,000 in calendar year 2012; and

WHEREAS, upon being appointed the new Receiver is authorized to appoint such deputies as he may deem necessary, within the budget allotted therefore;

NOW THEREFORE, BE IT RESOLVED that the Town Board of the Town of Glenville hereby appoints Patrick Aragosa as the Town of Glenville Receiver of Taxes on the terms stated herein to fill the vacancy created by the resignation by retirement of Joan Menhinick, thanks Joan for her many years of dedicated service to the Town and wishes her the best in her well-deserved retirement.
