# REGULAR MEETING OF THE TOWN BOARD TOWN OF GLENVILLE DECEMBER 19, 2012 AT THE GLENVILLE MUNICIPAL CENTER 18 GLENRIDGE ROAD, GLENVILLE, NEW YORK

Supervisor Koetzle called the meeting to order at 7:30 PM;

Supervisor Koetzle asked the Town Clerk, Linda C. Neals, to call the roll.

Supervisor Koetzle announced the two add on resolutions, authorizing the Animal Protection Foundation agreement for 2013 and one approving the budgetary amendments.

Supervisor Koetzle – "We have a nice occasion to be joined by the Burnt Hills/Ballston Lake Varsity Volleyball Team who won the State Championship this last November. We have invited them here tonight to honor them with proclamations.

The Board and I wanted to take this opportunity to acknowledge what a great achievement you had this past November. I had the opportunity this year to honor many of the teams from Burnt Hills/Ballston Lake School District for their State Championships. You had a phenomenal year, you and the rest of the teams. Your athletic directors should all be proud. This is one of my most favorite things to do is to take a moment and acknowledge the excellence we have in our Town."

# Town Council Reports:

Councilman Ramotar – "Last week Efficiency in Government Committee (EIG) held their final meeting of the year and they talked about some of the projects that they were deciding on based on the interviews with the department heads. They mentioned the following items, expansion of electronic records, online reservation system for parks, electronically available FAQ's where Town residents can get their own answers, developing approaches to seek grant money, investigation of possibly using free interns and streamlining court related paperwork. That is just a few of them and it looks like it is going to be a very busy EIG Committee next year and we are looking forward to it."

Councilwoman Wierzbowski – "I attended a meeting today of the Wellfield Protection Committee. They are getting very close to finalizing their report for us. They are hoping to have something to present to us at our work session in February. They are a great group of people who are very committed to helping us protect and preserve our water sources in the Town."

Councilman Boulant - "I would like to congratulate this Town Board. After three years we have tried to do everything that we said we were going to do when we ran. The Strategic Plan is working as you can see by the development. The financial restraints that we have and we are doing exactly what we said we were going to do. I'd like to thank everybody here for their efforts."

Supervisor Koetzle – "Item number 5 is a public hearing to consider a proposed local law to amend Chapter 255, "Vehicle and Traffic" of the Code of the Town of Glenville."

Supervisor Koetzle opened the public hearing at 7:45 pm.

Tom Melander, Traffic and Safety Committee – "Some of these changes are actually a result of a great collaboration between the Town, Town Board, Village of Scotia, Village Board, the School Board as well as the offices from the school district. We all worked together to bring all of these concepts together. The object is to have a safe area for the kids to go to school and what this does is this enables us in case we have to, to enforce the laws because these laws meet the requirements of the State and Federal Governments.

Also in this proposed change it includes some speed changes on Wolf Hollow Road which involved a big collaboration between the Town and the County in order to keep everything moving smoothly and safely for the residents in the Hoffman's area.

There is also a section in the proposed changes that involve changing the Town Code for the shopping centers. We have new shopping centers and the object there is that we don't want to have vehicles parked in front of the exits of all of the big stores because there is no place for people to come out except through those few exists and you want to be able to come out in case of an emergency."

Councilman Pytlovany – "I would like to thank Mr. Melander for all of his work and he is correct in saying that it has been collaboration between everyone. I would also like to thank the Town Traffic Safety Board for their input in this."

Supervisor Koetzle closed the public hearing at 7:48 pm.

No one wished to exercise the privilege of the floor.

# Supervisor's Comments:

Mohawk Ambulance finally received their \$50,000 Main Street Grant that we put in for them through National Grid. We will be setting up an opportunity to provide them with the funds, which are already here. We will be doing a presentation to them. This started back when they first started talking about coming to the old Envy Salon and we put in for this grant on their behalf. This is just like the grant we got for Mohawk Honda.

FEMA provided us with some notice regarding changes in the lock gates starting with Scotia going all the way to Fort Plain. They are responding to the issues that we had with hurricane Irene and Sandy and all of the flooding we experienced along the river. They are going to be doing structural changes to the locks so when there is flooding they can raise the gates and there would be no blockage underneath.

Our Organizational Meeting will be held on January 2, 2013. The Town Offices will be closed on Christmas Eve and Christmas Day as well as New Years Eve and New Years Day.

The lighting district, today the Governor announced what the regional councils will be funding and what, by default, they are not funding and unfortunately our lighting district is one that is not getting funding this year. We are disappointed in that obviously, we thought we had a good proposal. We thing it is still a very strong, good viable project and we will move forward with it. I have been in contact with Metroplex today making a case with Ray Gillen, that this is really an important project, not just for Glenville but for the County. If you go through the Town Center right now it is kind of weird, it is beautiful in one hand that we are starting to revitalize it but it is darker than I have ever seen it now. We really can't have a dark commercial corridor. There are three really important pieces to this one is energy efficiency where we replace old out dated lighting that is expensive with energy efficient lighting, also public safety, which as you drive through there and as we get sidewalks and people start walking through there we are going to need it and third is beautification it is so important for a town center to have that beautification to bring more businesses in and to bring more consumers in. I think for those reasons it is a perfect Metroplex and I think Mr. Gillen would agree if he were here.

I had an opportunity to meet the new tenants of the vacant Friendly's. We are very excited that we have a cultural draw here in the Town of Glenville, it is a sushi place, which we don't have in the Town, and it is called Neon Sushi. They are a great family and looking to open sometime in March.

Lastly, the Strategic Plan, we got all of your input from the work session. We are working on it now; Jim Martin got all of his information in today. I will put it together in some comprehensive format, get it out to everyone and then by the Organizational meeting we would have had a chance to see it."

## Discussion...

Supervisor Koetzle – "This is just our usual year-end clean-up budgetary transfers and it's essentially moving money between different accounts to cover where cash flow needs to be plugged or where fund balance needed to be used to cover expenditures. There is nothing on here that is really stands out but I ask every year for our Comptroller to explain things that are over \$25,000."

Supervisor Koetzle asked the Comptroller, George Phillips to give a brief explanation of items #4, 12, 20 & 30 as to why those items have to be transferred.

George Phillips – "# 4 is overtime cash out for dispatch services. \$38,000 is for one dispatcher that retired and the other \$30,000... in the detail expenditure reports, you get every month, it is consistent and every month we get a consistent answer from the Police Chief he can't control overtime, can't stop the cash out, and can't stop the accumulation, so that is what the \$30.000 is.

Item #12 is police, the same thing. No one retired from the police department as far as my recollection, again overtime has been very high through out the year and again similar answer, "can't control it". The good news is we hired three new officers and one dispatcher. Maybe next year after they get through training we can look for some kind of relief, but again that has been the consistent answer that we have gotten."

Supervisor Koetzle – "I just want to clarify because I thought the \$71,000 you're saying was a payout; you're saying it is overtime?"

Mr. Phillips – "\$38,000 of the \$71,000 was a payout for one individual who retired, the other \$33,000 or so was consistent with overtime.

Item #20 was a cash out for one individual in the highway department that retired.

Item #30 is principally due to Freemans Bridge Road repair that the Department of Transportation required us to repair a substantial amount of road at their discretion."

Supervisor Koetzle – "So these transfers from fund balance. Do they impact what was adopted under the Final Budget assumptions or were they already kind of...

 $\,$  Mr. Phillips - "They were already in our monthly forecast, they were consistent throughout the year."

#### **New Business:**

Councilwoman Wierzbowski – "I would just like to wish everyone a very Merry Christmas and a Happy New Year. It has been a pleasure working with all of you again this year."

Councilman Boulant - "To go back to resolution #214-2012 with George's comments; I understand where George is coming from, from the position he is being paid to do. I would like to add a few things. With us being pro-business and the world we live in today, highlighted with what happened in Connecticut on Friday, personally I don't see the overtime in the police department decreasing. Because we are pro-business, we are going to bring businesses into the community and the only reason we can bring them into the community is that number one we are pro-business, number two we have an exceptional public safety. With the element of the crime that we are experiencing today, with smash and grabs and domestic disputes and thing of that nature, our police force compared to other police forces is not anymore staffed if not understaffed compared to others. Councilman Pytlovany deals with them on a regular basis and I also deal with them too being in the business community. I get phone calls on a regular basis because I have cameras at my business and a lot of them point over at Walmart. They call me up and a detective would like me to go through the cameras because somebody stole something and they ran our way. I feel very safe with our police department and for us to nickel and dime it would be a totally negative of what we are trying to do. I get a little frustrated when we pound them because of the Chief not being able to explain the overtime. If you stood down there when they are bringing the element in, the criminals or what have you, I think for the amount of money we pay in overtime it's a minuscule thing for us to loose businesses and residents in this community. I am very happy with what our police department does and what we pay them."

Councilman Pytlovany – "I would just like to add one thing to Councilman Boulant's comments. In George's comments when they say it is uncontrollable, what he is saying is when they work overtime they put that into a bank and every officer has a bank and they can withdraw from that whenever they want to. So controlling actually how much money is paid out is really depending on how much the officer wishes to take out of the bank that year. I think that's where he is referring to that he doesn't have any control. He doesn't know how much overtime each officer is going to take. What he looks at is basically what they have been doing on an average and that's what we plan for. That is just a little bit of an explanation of why he said he can't control it, he can't control how much they take."

Supervisor Koetzle – "I would just like to wish everyone here and across the Town a very Merry Christmas, Happy Holidays, Happy New Year."
