REGULAR MEETING OF THE TOWN BOARD TOWN OF GLENVILLE MARCH 20, 2013 AT THE GLENVILLE MUNICIPAL CENTER 18 GLENRIDGE ROAD, GLENVILLE, NEW YORK

Supervisor Koetzle called the meeting to order at 7:30 PM;

Supervisor Koetzle asked the Town Clerk, Linda C. Neals, to call the roll.

Present: Supervisor Christopher A. Koetzle, Councilmen Alan Boulant, John C. Pytlovany, Sid Ramotar and Councilwoman Gina M. Wierzbowski

Also present were Attorney Michael Cuevas and Director of Operations James MacFarland, Comptroller Jason Cuthbert, Highway Superintendent Tom Coppola and Police Chief Michael Ranalli.

Town Council Reports:

spoke:

Councilman Ramotar – "The Efficiency in Government Committee met last week and two of the members will be working with Rockit Science to continue part of the Strategic Plan to enhance software and technology services within the Town. They will be interviewing department heads and employees to see how they are using the systems and how we can maximize on efficiency."

Councilwoman Wierzbowski – "On March 6th, I had the pleasure of taking the Cub Scouts Pack 4 from Glenville on a tour of the Town Hall. They were a great group, they thoroughly enjoyed themselves. They all wanted to be put in handcuffs. I would like to thank all of our employees for extending them the courtesies, to say hello and talk a little bit about what they do."

Councilman Boulant – "We have a long standing business on Freemans Bridge Road that will be relocating. Carbone's Carpet has been a fixture on Freemans Bridge Road for many, many years and they are going to be relocating to their warehouse facility on Craigie Avenue in the Village of Scotia. They are still in business. Their building is being purchased by Mohawk Honda to increase their parking."

Councilman Pytlovany – "I attended the DARE Advisory Board meeting on Tuesday, March 12th. Officer Dunbar has completed the DARE Program in Glen Worden and Glendaal Schools. He has just started the program at Pashley School.

There will be a DARE family bowling at Burnt Hills Lanes on Saturday, April 27th at 1:00 pm. Kids' prices are \$5.00 which includes bowling shoe rental, a piece of pizza and soda. On June 1st we are going to have our Annual Golf Tournament which is a major fund raiser for the program, the price is \$90.00 which includes coffee and pastries, golf, cart rental, lunch, dinner buffet and door prizes.

Yesterday I sat on the interviewing panel while we conducted interviews for the vacant detective's position in the police department. There were seven (7) candidates that had an interest in the position, at the end of the day the panel selected Justin Bolle. Justin has been with the police department for seven (7) years and has attended many police training classes offered by the State. He has an associate's degree in criminal justice from Sage College of Albany. It was a very difficult decision because many of them would have done an excellent job. Justin will be promoted when our new officers finish their field training. This position was included in the budget."

Supervisor Koetzle opened the Privilege of the Floor; the following people

this Board's decision to vote on a proposition to repeal the SAFE Act. On the grounds that this Act is radical, illogical and infringing on the rights of the people, guaranteed by the U.S. Constitution and Bill of Rights, Amendment II. She further stated that it is our right to speak freely and peaceably, assemble and petition the government for a readdress of grievances.

Ms. Ramotar stated that the fact that this law was rushed with no due process is and should be a matter of utmost concern. She further stated that the right of the people to keep and bear arms shall not be infringed.

She thanked the Board for standing up for our country while we still can.

Charles Beers III, 1137 Sacandaga Road – Mr. Beers also spoke in support of the Board's decision to vote on a proposition to repeal the SAFE Act.

He expressed his concern that our legislature has taken steps in secrecy and in the private darkness of their chambers to try to legislate away fear that comes from an object that has no decision making ability, not different than a pen or a computer.

He stated that when he read the resolution it made him proud of the Town of Glenville, proud of the people who came to support it and he thanked the Board for their time to pin it down.

He thanked the Board for their time and told them that the people in attendance this evening greatly appreciate their effort.

Tom Bovino, 107 Berkley – Mr. Bovino supports the proposition to repeal the SAFE Act. He talked about gun rights. He stated that this could very well be religious rights, freedom of speech rights, and freedom of assembly rights. He also mentioned that this was put through the legislature in the dark of night with a message of necessity.

Jason Fagel, 610 Sanders Road – Mr. Fagel thanked the Board for proposing the resolution for the repeal of the SAFE Act. He supports the resolution.

Jake Palmatier, 39 Gleason Road – Mr. Palmatier thanked the Board for endorsing this resolution. Mr. Palmatier stated that the people that are in favor of the SAFE Act are trying to paint the opponents of the SAFE Act into certain stereo types. He informed the Board that when Occupy Albany and Tea Party groups get together to oppose the same thing, that's got to tell you something is wrong. He stated that this isn't about guns, it's about civil rights.

Eric Tucker, Glenville resident – Mr. Tucker is an NRA certified home safety instructor. He also supports the resolution to repeal the SAFE Act. He stated that one of the things in this Act is a call for the universal registration of firearms. The law actually weakens our ability to prevent felons from owning firearms. He thanked the Board for all of the work that they put into this.

Supervisor's Comments:

Supervisor Koetzle shared the following information:

Tomorrow night, March 21st, is the Alplaus Residents Association meeting at 7:00 pm at the firehouse.

We met with energy consultants to look at plans to rebid the town's electric contract that expires in October. The resolution authorizing the bidding and approval process will be coming in April.

The Town's Local Development Corporation (LDC) has hired council and will be coordinating with Attorney Cuevas.

We just finished a conference call with Roosevelt & Cross detailing our 2005 bond refunding. Our savings have increased from the estimates given on February 21st. The final net present value savings is \$556,000 or an average of \$39,000 per year from 2013 through 2026.

The annual budget savings, not adjusted for present value, average just under \$45,000 per year and the total present value savings between last years refund and this one is over a million dollars.

The Budget and Finance Committee created for us at our request something called the "Employee Compensation Statement", which basically is given to each employee that shows the total compensation package per employee. This is designed to give everyone the same point of frame on how much the town actually pays toward compensation. It's not just about salary; it's about all the benefits involved. We talk about being under the 2% tax cap; things like health insurance have gone up 3 - 4% which is double the 2% cap that we are under. NYS Retirement, last year, went up approximately 17 - 18% statewide. This statement that we put together is quite enlightening for people to take a look at and each employee got a chance to take a look at it. For example we have an employee who makes \$85,000 and when you factor in things like longevity, comp time, holiday pay, uniform allowance, and shift differential and when you put the net benefits paid health insurance, dental insurance, vision, NYS Retirement, disability, life insurance, and memberships to gyms that \$85,000 employee is a \$126,000 cost to the Town. It is not the employee's fault but we have to all understand what the true cost is.

Regarding the SAFE Act, I just want to say that I am always very, very proud to serve the people of Glenville and I am very proud of the people in Glenville. Tonight here with the showing I am very proud of our Town. Standing up for their rights, coming here in this forum to express their opinion is really what this country is all about. This is really the only government, besides the county, that people can actually come and address the elected officials and to have their voice heard. My only frustration is that we don't have more power in this whole thing but as I said we had a great display of concerned Americans and citizens here tonight.

WHEREAS, the Town of Glenville has more than 100 employees and retirees covered under its health insurance plans and needs to hire an actuary to perform an analysis under Government Accounting Standards Board (GASB) Statement No. 45 to value its post employment benefit obligations other than pensions (OPEB) in order to be able to complete its 2012, 2013, and 2014 financial statements and single audits; and,

WHEREAS, the Town of Glenville on September 5, 2012 adopted Resolution 146-2012 accepting a lowest responsible bid of \$4,250 from Jefferson Solutions, Inc. for the two year period of 2012 and 2013 for the GASB Statement No. 45 valuation of OPEB for the Town; and,

WHEREAS, upon further review of GASB 45 requirements the Town must perform a new actuarial valuation every three years and not every two years as previously believed; and,

WHEREAS, Jefferson Solutions, Inc. has agreed to add the OPEB valuation necessary for the Town to complete its 2014 financial statements to the contract adopted in Resolution 146-2012 for an additional cost of \$700, resulting in a three year cost of \$4,950; and,

WHEREAS, this revised contract reduces the annual amount of the Town's required GASB Statement No. 45 valuation of OPEB from \$2,125 per year to \$1,650 per year; and,

WHEREAS, the services of an actuary are professional services exempt from competitive bidding requirements and the Comptroller recommends the services of Jefferson Solutions, Inc. based upon their previous low bid and their timely and professional performance of the prior GASB 45 analysis;

NOW, THEREFORE, BE IT RESOLVED, that the Glenville Town Board hereby authorizes the purchase of actuary services from Jefferson Solutions, Inc. to value the Town's liability for the post employment benefits other than pensions (OPEB) pursuant to GASB Statement No. 45 for the years 2012, 2013, and 2014 at a total cost not to exceed \$4,950.

Discussion...

Councilwoman Wierzbowski – "I would like to thank all of you for coming. Before I got involved in public service I rarely came to a meeting such as this. When I see the room filled to capacity, like this, it makes me feel very proud and very happy because anyone that has followed this Board knows that we believe in transparency and openness in government and we can't govern without you. You elected us, you put us here, and we represent you. It is very easy to get caught up in the power of your own decision making if you sit in a position such as this or one higher but the most important thing that I find that I have tried to remember in everything that I do when I am representing all of you is that it is not what's important to me it's what important to you and what you tell me you want us to do. I think it is appalling that our State government operates in the manner that it does and to a certain extent our county government. Openness and transparency in government is the only way to govern. When we start passing laws behind closed doors in the middle of the night it is a dark day for nation. I would like to thank all of you once again for coming and for supporting us. I am very proud to be sitting here and I am very proud to represent all of you."

Councilman Boulant – "The Retired Police Association", State of NY, has 5,000+ experienced law enforcement officers that are opposed and outraged by the legislation. NYS Sheriffs Association, the majority have already voted against the legislation stating that the SAFE Act is unworkable and unenforceable. I would also like to note that at the present 51 of the 62 counties in NYS, oppose and have passed resolutions to appeal the proposed legislation.

I heard today that Comptroller DiNapoli has pulled pension funds from the Remington Arms in Ilion, NY. This is bad business and it is going to have a negative impact on the economy in upstate NY and you have Senator Gillibrand out their toting their efforts for economy in upstate NY.

It would be really nice if common sense at some point in our life could govern what we are doing here because it's obviously not working at the state level."

Councilman Pytlovany – "I would like to thank everybody for coming here tonight and especially those who spoke and articulated their concerns very well. It was very good for me to hear that specifically from somebody, so thanks again."

Councilman Ramotar – "I would also like to thank everyone for showing up here tonight. It feels like this law was put in place to control and contain not to protect and when that happens that's a problem."

Supervisor Koetzle – "I would like to thank our attorney Mike Cuevas who did a phenomenal job crafting this resolution. I want to say too, I believe the Governor and the Legislature calculated and they calculated wrong. I think they thought that everyone was going to just roll over and accept this. I think it is clear that we are not going to roll over and accept this. I am very proud of all the work you have done on this on our behalf as residents trying to make sure that we can stand up for our rights here on a local level and at least hopefully try to get the State to do the same.

Perhaps the favorite, for me, paragraph in this resolution is the one that talks about our responsibility as elected officials to have sworn an oath to uphold and defend the Constitution and the Law of the United States. I understand that there are no rights without limitation; we all know that even our first amendment has limitations on it but this clearly, the NY SAFE Act, I believe in my humble opinion, has gone too far. I wish we had more power then we have here, obviously all we can do is express our opinion to the State Officials, but if we did nothing more today then fulfill our oath to stand up and protect the Constitution then I think our job was done.

I got a lot of emails and calls throughout the week and I did receive a few that were opposed to us passing this resolution. I had one resident tell me that they will no longer vote for me if I support this resolution and I explained to her that I don't make political calculations when it comes to things like this. I have to vote my conscious and I think she has to vote her conscious and I told her that I respected her decision not to support me any longer because I supported this. But if I didn't follow my conscious, if I made a political calculation on this then I would not be worthy of public service and I have to say that this Board is really a board of leaders not politicians, people think of elected officials as politicians sometimes but everybody on this board is a leader and I am proud to serve with each one of them. I have been told by some of them that this isn't our fight, that we don't have anything to do with the second amendment but I have got to tell you right now if there is an assault on the Constitution it is all of our fight, everyone of us has to fight for that.

I am very proud to support this resolution. I think Mike did a masterful job

and an eloquent job in making sure that we let our elected officials know where we stand on it."

RESOLUTION NO. 76-2013

Moved by: Councilman Boulant **Seconded by:** Councilman Pytlovany

WHEREAS, on the opening day of this year's session of the New York State Legislature, Governor Cuomo introduced a bill, entitled the New York Safe Ammunition and Firearms Enforcement Act (NY SAFE Act) and called for immediate consideration by the legislature through the use of a "message of necessity"; and

WHEREAS, despite the comprehensive and far reaching nature of the Governor's proposal, neither the bill text nor a summary of the bill's provisions were provided to the press or the public prior to its introduction, providing no opportunity for public input or comment prior to the bill's submission to the legislature for a vote; and

WHEREAS, at the Governor's urging, the Legislature passed the bill, even though many of the legislators hadn't had sufficient time to read it, much less analyze it or consult with constituents or experts regarding its contents; and

WHEREAS, once able to review the bill, experts from many fields recognized errors, omissions, cost impacts, enforcement difficulties and legal and ethical problems with the bill; chief among these were provisions that appear to infringe upon the Second Amendment rights of law abiding citizens and the potential confiscation of property by the government without compensation; and

WHEREAS, the Second Amendment to the U.S. Constitution, states, "A well regulated militia, being necessary to the security of a free state, the right of the people to keep and bear arms, shall not be infringed." and the U.S. Supreme Court has recently interpreted that constitutional provision to mean that U.S. citizens have a right to possess and bear arms for traditional purposes, including the protection of their home, <u>District of Columbia v. Heller, 554 U.S. 570 (2008)</u> and that the constitutional prohibition against infringement of these rights applies to the states, <u>McDonald v Chicago, 561 U.S. 3025</u>; and

WHEREAS, the New York State Civil Rights Law contains language similar to the Second Amendment to the U.S. Constitution; and

WHEREAS, the members of the Town Board of the Town of Glenville, like all elected officials in New York, have sworn to uphold and defend the Constitution and laws of the United States and the Constitution and laws of the State of New York; and

WHEREAS, a review of the bill also revealed certain provisions that would enhance penalties for those using illegal weapons in the commission of crimes, that would extend Kendra's Law to provide longer periods of treatment for those with severe mental disorders and would ensure that these persons don't "fall through the cracks" in the mental health care system, and provisions that could make schools safer by cooperative efforts of law enforcement and school personnel and by providing specific funding for school safety plans; and

WHEREAS, New York State Senator Kathleen Marchione has introduced a bill which seeks to repeal those provisions of the NY SAFE Act that contain errors, omissions, unfunded mandates, enforcement problems and which appear to violate the Second Amendment to the U.S. Constitution; and

WHEREAS, residents of the Town have appeared before the Town Board to express their concerns with the NY SAFE Act have requested that the Town Board convey its thoughts to the Governor and the Legislature;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the

Town of Glenville hereby finds and declares that the means employed by the Governor to push the NY SAFE Act through the Legislature violate the spirit, if not the letter of the law, in denying the citizens of New York the opportunity to be heard on this significant legislation; and

BE IT FURTHER RESOLVED that the Town Board of the Town of Glenville expresses grave concern with many of the provisions of the NY SAFE Act that appear to infringe upon the Second Amendment rights of New Yorkers, while acknowledging that some provisions of the NY SAFE Act have merit and can provide benefits to public safety; and

BE IT STILL FURTHER RESOLVED that the Town Board of the Town of Glenville finds the bill introduced by Senator Kathleen Marchione S.3948 which would repeal the provisions of the NY SAFE Act that infringe upon Second Amendment rights, while retaining the provisions that can benefit New Yorkers, would best serve the residents of the Town of Glenville and the State of New York and urges our state representatives, Senator Hugh T. Farley and Assemblyman James N. Tedisco to support Senator Marchione's bill S.3948 and urges Governor Cuomo to do the same and directs that the Town Clerk transmit copies of this resolution to our state representatives and the Governor.

A RESOLUTION AUTHORIZING FILING AN APPLICATION WITH THE OFFICE OF THE NEW YORK STATE COMPTROLLER PURSUANT TO SECTION 90.10 OF THE LOCAL FINANCE LAW FOR REFUNDING BONDS OF THE TOWN OF GLENVILLE, SCHENECTADY COUNTY, NEW YORK. WHEREAS, the Town of Glenville, Schenectady County, New York (hereinafter, the "Town") heretofore adopted a resolution authorizing the issuance of an aggregate principal amount of \$6,900,000 Refunding (Serial) Bonds, 2013 (the "Refunding Bonds") on February 20, 2013; and

WHEREAS, the Town Board previously authorized the Town Supervisor to enter into various agreements and perform other acts in furtherance of the issuance of the Refunding Bonds; and

WHEREAS, the Town will be obtaining the approval of the New York State Comptroller in connection with the issuance of the Refunding Bonds;

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of the Town of Glenville, Schenectady County, New York, as follows:

<u>Section 1.</u> The Town Supervisor, as chief fiscal officer of the Town, is hereby authorized to file an application with the Office of the New York State Comptroller for approval of the issuance of the Refunding Bonds, as authorized by that bond resolution dated February 20, 2013, pursuant to Section 90.10 of the Local Finance Law.
