REGULAR MEETING OF THE TOWN BOARD TOWN OF GLENVILLE OCTOBER 2, 2013 AT THE GLENVILLE MUNICIPAL CENTER 18 GLENRIDGE ROAD, GLENVILLE, NEW YORK

Supervisor Koetzle called the meeting to order at 7:30 PM;

Supervisor Koetzle asked the Town Clerk, Linda C. Neals, to call the roll.

Town Council Reports:

Councilman Ramotar – "On Sunday, October 20th at 11:00 AM "Paws for the Cause 4K Walk" will be held in Indian Meadows Park."

Thank you to all of the volunteers that were involved in 'Oktoberfest".

Councilwoman Wierzbowski – "Leaf season is approaching and the town will soon be picking up loose leaves. Place them on your property near the roadway but not in the road."

Councilman Pytlovany – "I attended the tour of the new Unified Communication Center (UCC) in Rotterdam. It is scheduled to be completed by November 1st."

The following people spoke during privilege of the floor:

Jim Valachovic – Mr. Valachovic thanked the Town Board members, employees and the many volunteers for their involvement in Oktoberfest.

Supervisor's Comments:

Supervisor Koetzle shared the following information:

Thank you to all who made the Oktoberfest such a great success. We are still getting numbers on how many people attended.

A gentleman came up to me during the event and told me he was up at Saratoga's festival and it cost him \$3.00 to park and \$10.00 to get in.

Councilman Ramotar and I attended the ribbon cutting last week for a new business on Freemans Bridge Road, Duell Plumbing Services. Baptist Health will have their ribbon cutting on October 18th at 1:00 p.m. I received a call from Maritime Center that Saratoga Academy would be having their grand opening on October 8th.

The Chamber will be having their business awards dinner on October 22nd at 5:30 p.m. at the Glen Sanders Mansion. They will be recognizing our own Ed Capavoni.

I attended the Local Development Corp. meeting (LDC) as the ex-officio and just to report back their progress is going forward. They have interviewed the auditors for the organization. They discussed funding of a potential business already so there are already opportunities in the pipeline for them. They also discussed a poll that they are conducting on line from residents on what they want to see here in the Town.

You all received the budget which was filed with the Town Clerk on September 30th.

I just want to go through some of the highlights of the budget just to key you in so as we go forward between now and November 20th.

Our state tax cap this year is 2.54%. The budget that I proposed is at 1.59%, so that is a total tax levy of about \$133,000 increase. Total appropriation increase \$344,000, all of that is retirement payouts that I budgeted for because at this point we do not know who is retiring and who is not retiring. All we know is who is eligible to the question is, is \$296,000 enough or is it too much? We certainly don't want to over estimate but we have got to have this conversation. It is a little uncomfortable with these potential retirements as we go forward.

This budget includes almost a \$50,000 increase in health insurance and workers compensation expense. Between those two expenses that's our increase in appropriations. If it wasn't for those two things in the budget we would have a decrease in appropriations.

We reduced the use of fund balance appropriations by \$45,000 that represents a 9% reduction. That is less than what my goal has been in the past. We have been at 15% but in light of the retirement payouts, the cash we have to put in that, we thought we would set that back a little. I really didn't want to but I think we have to.

It does include 1% raises for management and non-represented employees that includes all elected full-time employees. That does not include part-time elected officials so it does not include the Supervisor, Town Board members or the Town Justices.

It does include a full year of the dispatch center being here for 2014. We have all heard that there is no way it is not going to happen by March 2014. You are all going to have to decide what you want to do; I decided it was prudent to at least fund it through the year.

I reduced the revenue for our franchise fee from \$335,000 to \$310,000 because Time Warner's payment to us has been decreasing. I think that people are either going to satellite or getting a lower cable package, but their franchise fee has been decreasing.

I did include paying cash for one police car the chief asked for three, I think we will get there but not in 2014. I think we can do something in 2013 to get at least one car. I opted not to do the bonding for all three cars. I just don't think, right now that is where we want to be. It also includes paying cash for four new pickup trucks for public works.

The other biggies are -I included the REDI fund economic and development from \$35,000 to \$40,000. I felt that they are under the cap, I'd like to continue those investments but I also want to include Scotia so we moved it to the A fund so we can do that for the first time.

I restored the S-G Senior Citizen's Center contribution from \$5,500 to \$6,500 which was the pre-tax cap level. If you recall we cut them to stay under the tax cap, now we are having a pretty good year and I think it is fair to bring them back to where they were and the same holds true with Freedom Park Foundation and the Scotia Memorial Day parade. We also increased the bulk item pick up from \$20,000 to \$30,000.

Councilwoman Wierzbowski — "I think it is remarkable that we are allowed 21/2% and we are a full percent lower and I think that is indicative of our budgeting over the last few years."

Councilman Ramotar – "Towns are charging fees which obviously are exceeding the tax cap and we haven't done that. Congratulations you are doing a great job."

Supervisor Koetzle – "I forgot to mention that we are the only municipality in the County now that still offers those services free. Rotterdam has just proposed it, if they enact it we will be the only one left.

Oktoberfest - this came from the Chair, Heather Peterson – She wanted us to at least be aware of what Oktoberfest meant to the community and from a volunteer's stand point. She put together the number of volunteer hours that went into this only during the event, not the planning of it:

Friday night 26 community hours Saturday 450 volunteer hours

Schenectady Jr. ROTC Group – 32 people at 7 hours each

Union College – 24 students

YMCA of Schenectady Rehab Program – 10 volunteers at 2

hours each

Sunday cleanup 26 hours (BH/BL students assisted with the clean up)
Total of 502 volunteer hours over three days to run this event is huge. We live in such a great community."

That the proceedings for the tax years 2008, 2009, 2010, 2011 and 2012 in relation to the property be settled on the following terms and conditions:

- 1. This settlement is made in resolution of all claims or proceedings with respect to the subject property's real property tax assessment for the tax years stated above;
- Approval of this settlement and all required authorizations and enactments by the necessary parties shall be made in good faith and as expeditiously as possible;
- 3. The provisions of the RPTL section 727, including RPTL 727 (2) shall not apply to this settlement. That is because the property has been reconfigured, re-conveyed and re-developed and improved with new structures and improvements.
- 4. In consideration hereof, the tax certiorari proceedings brought by the taxpayer shall be discontinued on the merits with prejudice and without costs to either party or against the other.
- 5. The parties agree that the Stipulation is entered into for good and valuable consideration, that it is the entire agreement of the parties, that it is made to resolve this litigation and shall not be offered in any other proceeding by any party as competent evidence of any fact, that the stipulation may be filed in the office of the Schenectady County Clerk and an Order may be entered, based upon the Stipulation by either party on notice to the other.
- 6. The parties will pay any refunds for overpayment of taxes in two equal installments, one due sixty days after entry of the Consent Order and the other one year thereafter

WHEREAS, it appears to be in the best interests of the Town to settle said matter as recommended by the Attorney for the Town and the Assessor without further attendant legal and appraisal costs; and

WHEREAS, the property is located in the Scotia - Glenville School District, and the District has no opposition to the proposed settlement;
