- o Proposed Changes to the Short & Long Term Disability Benefit Director of Finance & Administration Denise Vallee presented some changes to the Town's Short & Long Term Disability benefit to employees. The changes were the result of a change in the insurance company offering the benefit and included a weekly benefit payment plan rather than a monthly one. On a motion from Selectman Robitaille with a second from Selectman Oliver, the Board voted to authorize Chairman Zornio to sign the appropriate documents for the change.
- 4. Other Business: The Town Manager informed the Board that the Town had received an additional \$3,000. plus from the NH Dept of Safety, Homeland Security & Emergency Management.
