## TAXPAYER'S NOTICE

Notice is hereby given that your county, school and municipal property tax is due by November 13, 2008 and May 14, 2009. Interest will be charged on unpaid taxes at an annual rate of 11.0% beginning November 14, 2008 and May 15, 2009.

As per state law, the ownership and valuation of all real estate and personal property subject to taxation shall be fixed as of April 1. For this tax bill, that date is April 1, 2008. If you have sold your real estate since April 1, 2008, it is your obligation to forward this bill to the current property owner.

#### **INFORMATION**

- As a result of the money our municipality receives from the state legislature through the state municipal revenue sharing program, homestead exemption reimbursement and state aid to education, our property tax has <u>already</u> been reduced by 48%.

- After eight months and no later than one year from the date of commitment, a lien will be placed on all real estate for which taxes remain unpaid.
- If you are a qualified veteran, you may be eligible for a Veteran's Exemption. For more information, contact the Assessor's Office at (207) 222-1600.
