#### ADMINISTRATIVE REVIEW REPORT

#### ITEM 1: PUBLIC HEARING

**Site Plan Amendment:** Goodwill Industries, Northern New England, applicant, is proposing to convert 5,000 sq.ft. of warehouse space to wholesale space with construction of a drive aisle and canopy on 14.78 acres. The property is located at 34 Hutcherson Drive in the Gorham Industrial Subdivision on Map 12 Lot 17.005 in the Industrial (I) district. The applicant's agent is Curtis Neufield. PE of Sitelines.

#### ITEM 2: SUBDIVISION REVIEW

**Subdivision Amendment:** The Crossing at Tannery Brook, LLC, applicant, is proposing to increase the number of lots from the approved "The Crossing" Subdivision's 29 lots to 36 lots within the previously approved roads and drainage system layout on 21.11 acres. The property is located off Gray Road (State Route 202) on Map 30 Lot 18 in the Urban Residential (UR) district. The applicant's agent is John Riordan, PE, with SGC Engineering.

#### ITEM 3: PRE-APPLICATION DISCUSSION
