- 6. Recent Items Sent to Town Council with Committee Recommendations:
 - A. Review a petition from Dick Pratt to ban thru trucks on Files Road and make a recommendation to the Town Council (referred by Council on November 10, 2015).
 Committee recommendation (1-1-1 abstention) to Council to consider amending Streets and Sidewalks Ordinance. At its 1/5/2016 meeting, the Council action was as follows: Moved by Councilor Shepard, seconded by Councilor Benner and Ordered, that the Town Council schedule a Public Hearing for February 2, 2016 to consider amending Schedule C of the Streets and Sidewalks Ordinance to close Files Road to thru truck traffic. 1 yeas, 6 nays (Robinson, Hartwell, Shepard, Benner, Phinney, Roullard)
 - B. Review proposal to amend the Land Use and Development Code, Chapter VII, Impact Fees (F) by allowing the retention of impact fees consistent with a reasonable schedule. Review proposal to amend the Land Use and Development Code, Chapter VII, Impact Fees (F) by allowing the retention of impact fees consistent with a reasonable schedule, to the Ordinance and to discuss concerns with the South Gorham Sewer Study and report back to the Town Council (referred by Town Council on January 4, 2011).  Committee recommended (3-0) that the Council consider a rezone if two of three abutters to Faulkner property agree to a rezone and the rezone area is contiguous.
 - D. Review Gorham's Solid Waste Flow Control Ordinance to update, where appropriate, and to add language that commercial dumpsters must be clearly marked with the name and phone number of the contractor who owns it (referred by Council on May 5, 2015).
