Meeting Minutes of December 17, 2012

Members Present: Mark Bail, Louis Barry, and Mary McDowell.

Mr. Barry, Chair called the meeting to order at 6:30 P.M. and led the meeting with the "Pledge of Allegiance".

CITIZEN PARTICIPATION

Gary & Andie Donicz of 355 East State Street came in front of the Board to ask if they would waive the fee of \$25.00 for a replacement sticker for the landfill as his wife lost her sticker and they have looked everywhere. They just paid for two stickers in December. Mary McDowell does not think that a waiver should be granted it is only \$25.00 and it is not our policy to waive the fee. Mr. Barry said that it is not often that this happens and should be done on a case by case bases. On a motion by Mark Bail and seconded by Lou Barry the following vote was taken, Lou Barry yes, Mark Bail yes, and Mary McDowell yes. The fee was waived.

NEW BUSINESS AND INFORMATION

On a motion by Mary McDowell and seconded by Louis Barry, it was unanimously voted to approve note 431-1 thru 431-5 serial notes each for \$37,600 with a total amount of \$188,000 at a rate of 1.90 % at United Bank.

Tax Classification Hearing-Board of Assessors: Louis Barry opened the tax classification hearing. Louis Barry read the hearing advertisement. Mr. Barry turned the meeting over to Mr. Bill Porter, who reviewed the FY2013 tax rate forms with the Board.

The total Town valuation is \$575,710,782 of which \$9,719,000 was new growth. Residential makes up 92% of the total valuation. The average home value is \$230,906. The Board of Assessors also looked at the potential of shifting more of the property tax rate to commercial. The Board of Assessors recommended a single tax rate of \$16.34 per \$1,000 for FY2013.

On a motion by Mark Bail and seconded by Mary McDowell, the Board unanimously voted to approve a single tax rate for FY2013 of \$16.34 per \$1,000 as recommended by the Board of Assessors.

Mr. Martin requested the Board vote to authorize him to sign the electronic version of the LA5 form on their behalf. The electronic version is the one submitted to DOR to set the tax rate

On a motion by Mark Bail and seconded by Mary McDowell, the Board unanimously voted to, it was unanimously voted to authorize Christopher Martin to sign the electronic LA5 form on their behalf

GRANBY HISTORIC COMMISSION-GRANT-FUTURE GHC PROJECTS-(MOVED TO JANUARY 22ND MEETING)

TOWN ADMINISTRATOR

Mr. Martin presented to the Board Commitment Warrant # 13-1 from the Tax Collector. On a motion by Mark Bail and seconded by Mary McDowell, the Board unanimously voted to approve Warrant #13-1 in the amount of \$ 704,025.50.

Mr. Martin will be attending a conference call with the Superintendent of Schools, John Libera and MSBA.

Mr. Martin is also looking at the grant for the Forge Pond purchase and what needs to be done by the town.

Mr. Martin will be sending a letter to David Desrosiers about talking to the landfill monitors and making sure they know that if residents don't have a new sticker for 2013 they can not get into the landfill to dispose of their trash. He also wants him to remind the monitors that they need to come out of the hut to check the stickers.
