Meeting Minutes of July 1, 2013

Members Present: Louis Barry, Mark Bail and Mary McDowell.

Louis Barry, Chair called the meeting to order at 6:30 P.M. and led the meeting with the "Pledge of Allegiance".

NEW BUSINESS AND INFORMATION

Departmental Reports: On a motion by Mark Bail and seconded by Mary McDowell, the Board unanimously accepted the departmental warrants as read.

Maintenance Warrant: On a motion by Mark Bail and seconded by Mary McDowell, it was unanimously voted to approve and sign the maintenance warrants.

Dufresne Park Rental Permits: On a motion by Mrs. McDowell and seconded by Mr. Bail, the Board voted to approve and sign the following Dufresne Park Rental permit for July 20th Granby Athletic Association, cross country running race, permit was approved with no alcohol on premises.

Board was not comfortable with signing permits that have gone pass the date of the event. Board will approve upcoming permits pending full payment in the future. That will eliminate this problem in the future.

Approve and Sign Chapter 90 Reimbursement Requests: On a motion by Mary McDowell and seconded by Mark Bail the Board unanimously voted to approve the Chapter 90 Reimbursement Request for Project on Carver Street: Project approved on July 19, 2012 in the amount of \$70,385.07.

On a motion by Mary McDowell and seconded by Mark Bail the Board unanimously voted to approve the Chapter 90 Reimbursement Request for Project on West Street: Project approved on July 19, 2012 in the amount of \$104,755.2, this closes the project.

One-Day Liquor License (Wedding): Kerry Fugua, of Professional Pour requested a one-day liquor license for a wedding reception at Dufresne Park Pavilion on August 10, 2013. She is a licensed pourer. She will be purchasing from Yankee Spirits located in Sturbridge MA, which is on the ABCC accepted list. On a motion by Mark Bail and seconded by Mary McDowell, the Board unanimously voted to approve one-day liquor license for August 10th with the following restrictions: The only alcohol allowed on the premises will be malt and/or wine. Applicant must provide a \$1,000,000 insurance policy acceptable to the Town. All alcohol must be confined to the pavilion area and the open fields on either side of the pavilion. No alcohol is allowed to be possessed or consumed in the parking area, nor is it allowed near the playground area. No serving people under 21 years of age. No serving to intoxicated persons. No serving alcohol before 1:00 PM and after 7:00 PM on August 10, 2013.

Affirm Appointments: On a motion by Mary McDowell and seconded by Mark Bail the Board unanimously voted to affirm the candidates as presented by Town Administrator Christopher Martin on page 1(listed in the back of the minutes with corresponding expiring dates).

On a motion by Mark Bail and seconded by Mary McDowell the Board unanimously voted to affirm the candidates presented by Town Administrator Christopher Martin on page 2 with the following amendments (listed in the back of the minutes with corresponding expiring dates):

An opening for appointment for Director of Senior Services (Mr. Martin had Ann Andras name there, but she submitted a letter of resignation to him last week.) The Board should affirm an appointment of an Interim Director of Senior Services at their next meeting. A search Committee should also be appointed at the next regular Select Board meeting. Mr. Martin will get an ad out to the local papers by next week advertising for a Director of Senior Services. Mary McDowell thanked Ann Andras for her service for the Town of Granby for the last 3 years and the work she did for the seniors. The Board is hoping to have someone hired by September. Mr. Martin will put a notice up at each building looking for residents who would be willing to serve as an at-large member of the Search Committee and will send letters to Donna Wiley, Friends of the Elderly for two names and to Russ Anderson, chair of the COA Directors for two names. Mary McDowell will represent the Select Board on this committee.

Mary McDowell made a motion that was seconded by Mark Bail to affirm the appointment of Robert Cannon and Scott Wilson to the Finance Committee for terms ending 6/30/2016. The Board thanks Dana Ritter for his many years of service on the Finance Committee.

A member to the Financial Management Team was left blank by Mr. Martin as he was not sure what was happening with the HCOG with changes in personnel. If Mr. Martin has not heard back from Frank Merts by Wednesday concerning the email he sent him concerning these changes he will give him a call.

On a motion by Mary McDowell and seconded Mark Bail by the Board unanimously voted to affirm the candidates presented by Town Administrator Christopher Martin on

page 3 with the following amendments (listed in the back of the minutes with corresponding expiring dates):

Granby Energy Committee-Arthur Krulewitz resigned. Mary McDowell made a motion that was seconded by Mark Bail to affirm the appointments of Marie and Matt McCourt to the Granby Energy Committee for terms ending 6/30/2014

Granby Historic District Committee: The Board needs to follow the by-laws that presented to them by Terry Lajoie of the District Committee. Mr. Martin send letters to the Pioneer Valley Realtor's Association asking them for two nominees who belong to their association who live in Granby(preferably) and to Western Mass Chapter of the American Institute of Architects(located in Boston) for two nominees who belong to their association who live in Granby(preferably) also. Mr. Martin has not sent a letter to the Granby Historic Association, as he was not sure who the president was. The Board asked Mr. Martin to send the letter to Terry Johnson, who would need to give four nominees. Mr. Martin gave them two-weeks to respond. The Board would like the current members be invited to their next meeting on the 15th.

On a motion by Mary McDowell and seconded Mark Bail by the Board unanimously voted to affirm the candidates presented by Town Administrator Christopher Martin on page 4 with the following amendments (listed in the back of the minutes with corresponding expiring dates): Taking Herbert Abelson name off for the Pioneer Valley Planning Commission Representative. Adding Matthew McCourt as an Associate Member to the Parks Oversight Ad-Hoc Committee.

On a motion by Mary McDowell and seconded Mark Bail by the Board unanimously voted to affirm the candidates presented by Town Administrator Christopher Martin on page 5 with the following amendments (listed in the back of the minutes with corresponding expiring dates): Affirming appointment of Russell Anderson as Sexual Harassment Officer till June 30, 2014.

APPOINTMENTS

Mary Jo Mugnier-Annex: Mary Jo communicated to the Board that she was looking for updates/feedback from them concerning continued leasing of her property on 215-B West State Street. She has a 6-month lead-time for contract conversations. She will start negotiations in October of 2013 with other occupants who rent space from her. Granby's contract ends August 14, 2013. Is her property still an option for the Town? Lou Barry does not see any changes for the Town in the near future. The Board did think that the property would be feasible for a new town hall, but no formal decision was made, but they thought it would be unlikely. The Board would like Mary Jo to come to a Select Board meeting in October to discuss the Annex renewal contract.

Liquor License Hearing-(Beer & Wine):-moved to July 15th @ 7:30 pm

Kamenides-142 East Street: Mr. Kamanides came in front of the Board to ask that the Board lift the restrictions on his property for bikes not being displayed properly on his property. Mr. Kamenides read a statement to the Board concerning restoring bicycles and displaying them at his home at 142 East Street. He would like to work with the Board to

find a solution that will be acceptable to both parties. 14 abutters signed a petition saying that they did not find any problems with Mr. Kamendies continuing with displaying and selling his bicycles at 142 East Street. Mr. Joe Mahue, Batcherlor Street, former Planning Board member spoke on the behalf of Mr. Kamenides. The Board cannot make a decision one way or another it is not under their prevue. After much discussion on the Zoning Bylaw for this business, it was decided that Mr. Kamenides should go to Zoning Board of Appeals and get a special permit. The Board did ask Mr Demers (Building Inspector/Zoning Officer) to ask the court for a hold/waive on the fine paperwork until the Special Permit can be obtained. Mr. Barry will write a letter to Mr. Demers asking this.

Tangent-(Solar)-Update: Craig Dwyer came in front of the Board and gave them an update where they are in the process and requested for an extension on project. They looked at the two lots the Board the agreed to and felt they were not suitable. And would like an extension to look other town property on the Assessor's maps. The Board declined the request.

TOWN ADMINISTRATOR

Mr. Martin received a note from Michael Quesnel, chair of the School Committee, one member has resigned and they have three residents that were interested in serving for the unexpired term until the annual election next May. The Committee has interviewed all residents and have a name they would like to present to the Board and have appointed. Law dictates that a joint meeting must me held between the Select Board and School Committee to appoint the resident. Mr. Martin will ask that the School Committee come to the Select Board's next meeting on July 15.

Mr. Martin spoke with Dennis Setzco from AECOM as he said he would be available to help the town with applications for grants concerning having sewers continued from Pleasant Street to School Street, along the 202 corridor. They would also have to do an engineering study for the applications. Mr. Martin also spoke to a representative from USDA, who told him that this project could be available to get a grant up to 30% of the cost of the project. However, they have a concern that it may be a phased in project depending on the cost. AECOM gave Mr. Martin a cost estimate of the project @\$30,000 for them to do the work. Mr. Martin would like to know if the Board wishes to enter into a contract with AECOM for these services. The Board would like to have a meeting with the Planning Board, Board of Health, and Finance Committee to discuss this project before they sign any contracts. Everyone needs to be on the same page before moving forward on the project. The meeting will be held on Tuesday July 22. (Mary would like items like this and Kellogg Hall actually put on the agenda).

INFORMATION

Mary McDowell asked if an exit interview could be done with Ann Andras, Mr Martin said he had one scheduled for Wednesday morning. Mary asked if a Board member could attend. Mary will attend. The Board believes that this is a good policy to have an exit interview for anyone who leaves.

A senior-aide is now working 20 hours a week, working for both the Select Board office and Council of Aging office. These hours are not paid from any town budget. This is part of training program sponsored by Senior-Aide project from their Springfield office.

Mary McDowell asked about the phone system and Mr. Martin told her that project is still in process from changing the phones from OTT Communications to Comcast. Board suggested that Mr. Martin get a hold of Mr. Fitzgibbons if he does not get an answer soon from Comcast on a date for installation.

Solid Waste RFP: Moved to a two item agenda meeting for only this RFP and the appraisal for Kellogg Hall. The meeting will be held on Monday July 8th @ 3:00 pm.
