Meeting Minutes of January 5, 2015

Members Present: Mark Bail, Mary McDowell and Louis Barry, Others Present: Christopher Martin

Mark Bail, Chair called the meeting to order at 6:30 P.M. and led the meeting with the "Pledge of Allegiance".

CITIZEN PARTICIPATION

Richard Domeracki: Mr. Domeracki brought to the Board's attention that the article in the Sentinel a couple of weeks ago on the Town of Granby's tax rate had incorrect information. He would like to point out that median value of the property for FY2014 was incorrect at \$223,000. He spoke to the Assessor's office and the correct figure was \$210,000. That meant that the average price of property for FY2015 decreased only \$3000.00. Mr. Martin told Mr. Domeracki that the Board only uses the current median value when calculating possible increases for any proposition 2-1/2 proposed. The Board thanked Mr. Domeracki for coming in.

There was no citizen participation. On a motion by Lou Barry, seconded by Mary McDowell, the Select Board unanimously approved the adjournment of the pole hearing. (3-0-0)

On a motion by Lou Barry, seconded by Mary McDowell, the Select Board unanimously approved the application for the new SO pole on the intersection of Aldrich and Amherst Streets., plan #18394962. (3-0-0)

TOWN ADMINISTRATOR

State Clean Water Revolving Loan Program: Chris Martin informed the Board that he received a call from Deirdre Doherty of DEP concerning the final list of the approved projects under the State Clean Water Revolving Loan Program. The "Town of Granby" made the final cut. He has spoken with Dennis Setzko and has invited him to the Board's meeting on Jan. 20th to discuss the next steps. He also asked Dennis to check with Rural Development to see what our status is on that application. This is for the 7,594,000 sewer expansion project. This project is phase 1 of a 2 phase project for the expansion of sewer from 5-Corners to he believes West Street.

Kestrel Trust: Mr. Martin received an email from Ben Wright from Kestrel Trust concerning the Phelps Batchelor Street Conservation Restriction application. They need a signature on one more page for everything to be complete. On a motion by Mr. Barry, seconded by Mary McDowell, it was unanimously voted to authorize Mr. Martin to sign

on behalf of the Select Board the last paper needed for the Phelps Batchelor Street Conservation Restriction application to be complete.

Resignation: Mr. Martin reported to the Board that Robert Ash has retired from the Granby Police after 15-years of service as of January 04, 2015 to explore other avenues. The Board wishes him well in his future endeavors. He will be missed.

Christmas Tree Burning: Trees are being brought to Dufresne Park in the designated area and will be burned by the Fire Department on Wednesday January 7th. Mr. Martin noted via Chief Anderson the burning permits will be available from January 15-May 1.

OLD BUSINESS & INFORMATION

SHFD2: Mr. Bail explained that the Board had sent a letter requesting that SHFD2 meet with them to discuss our concerns about coverage for in fire for the Granby residents who reside in the SHFD2. The Board made suggestions to make things run smoothly for everyone.

- Mr. Barry read the letter the Board received back from SHFD2 concerning their request (letter included in back of minutes).
- Mark Bail the biggest problem with the situation that no one has the authority to decide between jurisdictions, not-OMES or the Fire Marshall's office.
- Board's concerns are that the residents get the services that they need with no confusion because of the problems between the two districts. Our basic requests were that we be allowed to dispatch our fire in an event of a fire, but be called off by SHFD if not needed
- Our Atty. told us not to agree with what SHFd2 wants because it opens the Town up for liability, and poorer service. Our Atty. made an MOU for the Town interests. They have to learn that we have a duty to protect our Town and our residents.
- Mary McDowell we have no problems in the past.
- Lou Barry said that you sometimes you really don't know what kind of situation you have until you get there. * Should not be dispatcher's problem to decide whose jurisdiction and hope they get it right, more pressure then there needs to be.
- SHFD2 does not have a 911 dispatch we only rely the call. Dumping the call you have no one to keep you posted on what is happening and what more is needed.
- It is not that we think that SHFD2 can't handle it; it is that we are concerned for the pubic safety of our residents.
- They have no jurisdiction over our dispatch. They can not tell us what we can do. We have do what we think is best for our residents.
- SHFD2 is no different then any other town we work with.
- We thought we gave them everything they wanted except dispatching. We conceded fire inspections, fire investigations, opened up parts of Granby that are not part of SHFD2 for dual responses. Should we meet with them again?
- Mr. Martin asked the Board if they could give a directive that he keep dispatching as he his department has always done, so that his department does not get caught in a ringer between the two districts, until further notice.

• Mr. Barry also wanted the same directive be done for the Fire Department as well.

On a motion by Lou Barry, seconded by Mary McDowell, the Select Board unanimously voted to give a directive to both the Police Chief and Fire Chief to continue dispatching and responding to fires in the SHFD2 as they have for the last umpteenth years. (3-0-0)

• Mr. Martin will send a letter that our Board has sent directives to our two Chiefs to continue dispatching and responding as they have done in the past years concerning fires in SHFD2. They also feel that any more meetings between the Town of Granby and SHFD2 are counter productive. The Board is under advice from Special Council that we continue to operate as we have done until instructed differently from a Court of Law or from a State Oversight Agency that says we are no longer responsible for that area.
