C Lalonde-Discussion-Taylor St- Rec'd letter that Mr. Brooks has been hired as a consultant. EC made a motion to continue, BS sec'd. All in favor.

K.Richards-East St- Attended by Mr. Richards and Atty. Myhrum. ConCom rec'd guidance from Atty. Ryan that we should rescind the enforcement order against the Richards. It can be reinstated at a future date, if needed. MADEP is moving forward with Solid Waste improper disposal. EC Made a motion to rescind the enforcement order against the Richards as crafted, with the understanding that we can reinstate it if needed. BS sec'd. All in favor. Richards' enforcement has been rescinded.

Emergency Beaver Permit-State-Green Meadow Lane- Rec'd letter from Integrated Wildlife Control- 39 Greenmeadow Ln need BOH Approval. ConCom does not have an approval at the meeting. BS said that he would review the site and if there is an approved permit in town hall, BS will sign it.

**Shawn Lamoureux-** within the ROW on 202, proposing a drainage swale and 2 culverts To drain under driveway. Rec'd curb cut permit. Reviewed the plan set and recommended he file an RDA.

Special permit for 56 Aldrich Street- setback requirement change. No issues noted. Forest Cutting Plan rec'd re: off Jackelyn Cir. AF went to a site visit with Wenda, DCR, and NHESP. They modified their FCP after they rec'd a "take" from NHESP requiring remediation actions.
