Jeanette Ingram presented plans that were revised per the State of Massachusetts request, which now include a smaller exclusionary property. Also included in the plan per the State's stipulation was an 80' access strip with frontage on Pleasant Street.

The description of the exclusion is:

Exclusion 2.750 acres +/- on the Westerly side of Pleasant St. Lot A: 0.025 acres +/- on the Westerly side of Pleasant St.

The Board approved and signed the revised plans. Two completed copies of Form A – Application for Endorsement of Plan were submitted to the Board.
